ANNIVERSARY

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. To commemorate its founding anniversary as a province,
2 March 8 of every year is hereby declared a special nonworking holiday in the
3 entire Province of Compostela Valley.

4 SEC. 2. This Act shall take effect immediately upon its approval.
