AN ACT RENAMING THE SAGRADA – LIDONG ROAD EXTENDING
FROM THE PROVINCE OF CAMARINES SUR TO THE
PROVINCE OF ALBAY AS DIOSDADO MACAPAGAL HIGHWAY

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. The Sagrada – Lidong Road extending from Sagrada, Buhi
2 in the Province of Camarines Sur to Lidong, Polangui in the Province of Albay
3 is hereby renamed as Diosdado Macapagal Highway.

4 SEC. 2. This Act shall take effect upon its approval.
