AN ACT NAMING THE SAN NICOLAS – SOLSONA PORTION OF THE
ILOCOS NORTE – APAYAO ROAD AS THE JOSEFA LLANES
ESCODA NATIONAL HIGHWAY

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. This Act shall be known as the “Josefa Llanes Escoda
2 National Highway Act”.

3 SEC. 2. The San Nicolas – Solsona portion of the Ilocos Norte –
4 Apayao Road starting from Km. Post 484+000 to Km. Post 524+000 in the
5 Province of Ilocos Norte is hereby named as the Josefa Llanes Escoda
6 National Highway.

7 SEC. 3. This Act shall take effect upon its approval.
