AN ACT RENAMING THE GAPAN – SAN FERNANDO – OLONGAPO  
ROAD (GSO ROAD) AS JOSE ABAD SANTOS AVENUE (JASA)

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The Gapan – San Fernando – Olongapo Road (GSO Road)  
2 is hereby renamed as Jose Abad Santos Avenue (JASA).

3           SEC. 2. All laws, decrees, orders and issuances or part thereof  
4 inconsistent herewith are hereby repealed or modified accordingly.

5           SEC. 3. This Act shall take effect upon its approval.
