
**MR. PRESIDENT:**

AN ACT UPGRADING THE VALENZUELA GENERAL HOSPITAL IN THE CITY OF VALENZUELA, METRO MANILA INTO A TWO HUNDRED BED CAPACITY TERTIARY LEVEL HOSPITAL TO BE KNOWN AS THE VALENZUELA MEDICAL CENTER AND APPROPRIATING FUNDS THEREFOR.

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1       SECTION 1. The Valenzuela General Hospital in the City of  
2       Valenzuela, Metro Manila is hereby upgraded from a one hundred bed capacity  
3       general hospital into a two hundred bed capacity tertiary level hospital to be  
4       known as the Valenzuela Medical Center, which shall be under the direct  
5       technical operation and administration of the Department of Health.

6       SEC. 2. The Secretary of Health shall include in the Department's  
7       programs the implementation of the increase in the bed capacity of the

1 Valenzuela Medical Center, the funding of which shall be included in the  
2 annual General Appropriations Act.

3 The increase in the bed capacity of the Valenzuela Medical Center from  
4 one hundred (100) to two hundred (200) beds shall be implemented for a  
5 period of not more than four years from the approval of this Act.

6 SEC. 3. The Secretary of Health shall issue rules and regulations  
7 necessary for the effective implementation of this Act.

8 SEC. 4. This Act shall take effect upon its approval.
