

REPEALING THE CRIME OF PREMATURE MARRIAGES IN ARTICLE 351 OF THE REVISED PENAL CODE"

#### "AN ACT

ABOLISHING THE THREE HUNDRED AND ONE (301) DAYS CRIMINAL PROHIBITION TO REMARRY AND ALLOWING THE REMARRIAGE OF A WIDOW OR A SEPARATED WOMAN FORTY (40) DAYS AFTER THE DEATH OF HER HUSBAND OR THE ANNULMENT OR DISSOLUTION OF HER PREVIOUS MARRIAGE, AMENDING FOR THIS PURPOSE ARTICLE 351 OF ACT NO. 3815 AS AMENDED, OTHERWISE KNOWN AS THE REVISED PENAL CODE"

#### "AN ACT

REPEALING ART. 351 OF ACT NO. 3815, OTHERWISE KNOWN AS THE PENAL CODE, ON PREMATURE MARRIAGES IN ORDER TO CORRECT ITS INHERENT DISCRIMINATION AGAINST WOMEN"

# "AN ACT REPEALING THE CRIME OF PREMATURE MARRIAGES IN ARTICLE 351 OF THE REVISED PENAL CODE"

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. The crime of Premature Marriages in Article 351 of the
- 2 Revised Penal Code is hereby repealed.
- 3 Sec. 2. Effectivity This Act shall take effect after fifteen (15) days
- 4 following the completion of its publication either in the Official Gazette on in a
- 5 newspaper of general circulation in the Philippines.
