AN ACT RENAMING THE OZAMIZ CITY BY-PASS ROAD LOCATED  
IN OZAMIZ CITY AS CONGRESSMAN HILARION J. RAMIRO  
BY-PASS ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The Ozamiz City By-pass Road in Ozamiz City is hereby  
2 renamed as Congressman Hilarion J. Ramiro By-pass Road.

3           SEC. 2. The Department of Public Works and Highways is hereby  
4 directed to implement the provision of this Act.

5           SEC. 3. This Act shall take effect upon its approval.
