AN ACT RENAMING THE BACOLOD – MURCIA – SAN CARLOS  
ROAD (BACOLOD SECTION) IN THE CITY OF BACOLOD TO  
ROMEO G. GUANZON AVENUE

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The 9.62 kilometer stretch comprising the Bacolod Section  
2 of the Bacolod – Murcia – San Carlos Road from the junction of Araneta  
3 Street to the boundary of Bacolod City and the Municipality of Murcia in  
4 Negros Occidental, is hereby renamed as the Romeo G. Guanzon Avenue.

5           SEC. 2. This Act shall take effect upon its approval.
