### AN ACT CREATING A BARANGAY TO BE KNOWN AS BARANGAY TUMANA IN THE CITY OF MARIKINA, METRO MANILA

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. *Creation of Barangay Tumana.* – Sitio Tumana in  
2   Barangay Concepcion Uno, City of Marikina, Metro Manila is hereby  
3   separated from Barangay Concepcion Uno and constituted into a new barangay  
4   to be known as *Barangay Tumana*.

5           The technical description of Barangay Tumana shall be as follows:

6           From the corner of Everlasting Street and Roxas Street, Twinville  
7   Subdivision going south, along the centerline of Rosas Street, J. del Rosario  
8   Street and Angel Santos Street; thence along the centerline of old Marikina  
9   River Course until it intersects the property of Wood Ridge Residential Estate;  
10   thence to the west along the property line of Wood Ridge Residential  
11   thence to the northeast between the property line of Wood Ridge Residential  
12   Estate and Loyola Grand Villas; thence to the northwest along Finland Street  
13   until it intersects Quezon City boundary; thence to the northeast along

1 Marikina-Quezon City boundary until it crosses Marikina River; and thence to  
2 the east along the centerline of Everlasting Street until it intersects the point of  
3 beginning.

4 SEC. 2. *Conduct and Supervision of Plebiscite.* – Pursuant to Section  
5 10 of Republic Act No. 7160, otherwise known as the Local Government Code  
6 of 1991, the new barangay shall exist upon the majority of the votes cast by the  
7 qualified voters of Barangay Concepcion Uno, City of Marikina, Metro Manila  
8 in a plebiscite to be conducted and supervised by the Commission on Elections  
9 (COMELEC) in the area affected, within ninety (90) days from the effectivity  
10 of this Act.

11 SEC. 3. *Barangay Officials.* – The first set of officials of the said  
12 barangay shall be appointed by the city mayor of Marikina and shall hold  
13 office until such time that their successors have been duly elected and  
14 qualified.

15 SEC. 4. *Public Infrastructures and Facilities.* – All existing public  
16 infrastructures and facilities for public use existing therein at the time of the  
17 approval of this Act are hereby transferred without cost or compensation and  
18 shall be administered by the new barangay.

19 SEC. 5. *Internal Revenue Allotment Shares.* – Barangay Tumana shall  
20 be entitled to Internal Revenue Allotment (IRA) shares pursuant to Section  
21 285 of Republic Act No. 7160, otherwise known as the Local Government  
22 Code of 1991.

23 SEC. 6. *Appropriations.* – The amount necessary to conduct the  
24 plebiscite as provided for under this Act shall be borne by the City of  
25 Marikina, Metro Manila.

26 SEC. 7. *Effectivity.* – This Act shall take effect upon its approval.
