**EXPLANATORY NOTE**

In a report by the United Nations Development Program's Human Development Index, Philippines is among developing countries that are "dynamic adopters" in terms of technological achievements and capacities. Philippines has been one of the few countries losing its technically trained people to the United States. Between 1994 and 1995, some 57,000 Filipinos who hold higher education degrees were "imported" by the United States of America, averaging nearly a thousand highly skilled individuals per year.

Every year, more than 800,000 Filipinos leave for jobs abroad and the share of persons with higher education or with sophisticated technical skills have been growing in the recent years. The Philippine economy benefits substantially from these through dollar remittances of Filipinos employed abroad. However, although remittances are significant source of foreign exchange, the money is typically spent on consumer goods and adds little to the economy's productive capacity.

The proposed bill aims to tap the expertise of the overseas Filipino professionals to help accelerate economic development of the country in order to meet the goals towards the next millennium. It provides for the methodologies by which overseas Filipinos may effectively assist the development of the country's economy, particularly in the areas of transfer and exchange of technology. Moreover, it is worth mentioning that their desire to come back to their land of birth is coupled with a desire to contribute skills for the development and progress of the country. Hence, by allowing them to practice in the Philippines, we give them an opportunity to render service to the country where their skills and expertise will be most needed and welcomed.

Early cognizance of this bill is earnestly sought.



**AN ACT  
PROVIDING FOR THE TRANSFER IN THE PHILIPPINES OF SCIENCE AND  
TECHNOLOGY RELATED PROFESSIONS BY OVERSEAS FILIPINO  
PROFESSIONALS, APPROPRIATING FUNDS THEREFOR AND FOR OTHER  
PURPOSES**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           **SECTION 1. Policy Declaration.** - Science and technology is essential in national  
2 development and progress. In pursuance of this objective, the government shall enlist the  
3 participation of Filipinos overseas, particularly high- level scientists, engineers, information and  
4 communications technology experts, and other professionals in various technical fields, and shall  
5 provide proper incentives and programs so as to secure their services in priority development  
6 areas of the public and private sectors, with the view of promoting information exchange and  
7 contributing to the modernization and industrialization of the country.

8  
9           **SEC. 2. Incentives.** - Given the significance of upgrading technologies and productivity  
10 of the people in pursuit of national economic development, the Government shall develop and  
11 provide adequate incentives to Filipino expatriates whose expertise and training can play a vital  
12 role in the industrialization efforts of the country. Among the incentives to be provided shall be,  
13 but not limited to, the following:

14           a. Exemption from payment of the travel tax for grantee;

- 1           b. Availment of the privilege granted under Section 105(g) of the Tariff and Customs  
2           Code of the Philippines (TCCP) which provides for the conditionally-free importation  
3           of wearing apparel, articles of personal adornment, toilet articles, portable tools and  
4           instruments, theatrical costumes and similar effects which are necessary and  
5           appropriate for the wear and use of such persons but not for barter, sale or hire; and  
6           c. Financial support for research and development projects approved by the Secretary of  
7           the Department of Science and Technology.

8  
9           **SEC. 3. *Implementation.*** - The Department of Science and Technology and the  
10          Department of Foreign Affairs shall develop and implement appropriate measures to ensure  
11          attainment of this Act, to include the Balik Scientist Program under Executive Order No. 130, as  
12          certified by the Department of Science and Technology.

13  
14          **SEC. 4. *Practice of Overseas Professionals in the Philippines.*** -- The Professional  
15          Regulation Commission may, upon recommendation of the concerned Professional Regulatory  
16          Board, authorize the registration without examination and the issuance of a certificate of  
17          registration and a professional license to any Filipino, whether or not he has lost his citizenship  
18          when he was overseas, who has been in the practice of his profession in a foreign country or  
19          state, subject to the provisions of this Act.

20          The application for registration without examination and the issuance of a certificate of  
21          registration and a professional license may also be granted to any Filipino who, prior to his  
22          departure abroad, has already been granted certificate of registration and a professional license,  
23          by appropriate Philippine professional regulatory board to practice his profession, but said  
24          registration or license has expired while he was overseas.

1           **SEC. 5. *Qualifications.*** - For the registration without examination and the issuance of a  
2 certificate of registration and a professional license under the Act, the applicant must submit  
3 proof that:

4           a. He is a present or former Filipino citizen, as shown by his birth Certificate or other  
5           documentation as may be required;

6           b. He is at least twenty seven (27) years of age;

7           c. He is registered and holder of a valid certificate of registration and/or valid  
8           professional license to practice his profession issued by the appropriate Philippine  
9           regulatory commission prior to his departure abroad, or by a government body  
10          concerned in a foreign country or state whose requirements for registration or licensing  
11          are substantially the same as those required and contemplated by Philippine laws;

12          d. He is a person of good moral character, he has not been convicted of any crime  
13          involving moral turpitude nor sanctioned administratively by any government  
14          instrumentality including the body that regulates the practice of his profession.

15  
16           **SEC. 6. *Requirements.*** - The applicant shall file an application under oath stating his  
17 personal circumstances, his intention to practice in the Philippines and the office address that he  
18 will be using, and his undertaking to abide by all regulations pertaining to the practice of the  
19 profession in the Philippines.

20  
21           **SEC. 7. *Implementing Guidelines.*** - The Department of Science and Technology,  
22 Department of Foreign Affairs, and the Professional Regulation Commission, in coordination  
23 with other concerned government agencies, shall within ninety (90) days upon the approval of  
24 this Act, promulgate the necessary guidelines to put into effect the purposes and provisions of  
25 this Act.

1           **SEC. 8. Appropriations.** – the amount necessary for the implementation of this Act shall  
2 be sourced from the General Appropriation of Department of Science and Technology.

4           **SEC. 9. Repealing Clause.** - All laws which are inconsistent and contrary to the  
5 provisions of this Act are hereby repealed or amended.

7           **SEC. 10. Effectivity.** - This Act shall take effect fifteen (15) days following its complete  
8 publication in the Official Gazette or at least two (2) newspaper of general circulation, whichever  
9 comes first.
