

AN ACT RENAMING FLORIDA ELEMENTARY SCHOOL
SITUATED IN BARANGAY FLORIDA, BUTUAN CITY, INTO
MARIANA L. PINEDA MEMORIAL ELEMENTARY SCHOOL

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. *Renaming of School.* – Florida Elementary School
2 public elementary school situated in Barangay Florida, Butuan City, is
3 hereby renamed and henceforth shall be known as Mariana L. Pineda
4 Memorial Elementary School.

5 SEC. 2. *Repealing Clause.* – All laws, decrees, executive orders and
6 other administrative issuances and parts thereof which are inconsistent with
7 the provision of this Act are hereby modified or superseded accordingly.

8 SEC. 3. *Separability Clause.* – If any clause, provision, paragraph
9 or part hereof shall be declared unconstitutional or invalid, it shall not
10 affect the remaining provisions of this Act.

11 SEC. 4. *Effectivity.* – This Act shall take effect upon its approval.
