



*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled*

1 SECTION 1. *Renaming of a National High School.* The name of the
2 Babatngon National High School in the Municipality of Babatngon, Province
3 of Leyte is hereby changed to Juan S. Tismo National High School

4 SEC. 2. *Effectivity.* - This Act shall take effect fifteen (15) days after
5 its publication in the *Official Gazette*.
