





AN ACT ESTABLISHING A NATIONAL SCIENCE HIGH SCHOOL IN
BARANGAY DOS, LAS PIÑAS CITY TO BE KNOWN AS THE
LAS PIÑAS CITY NATIONAL SCIENCE HIGH SCHOOL AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Establishment of a National Science High School.* – There
2 is hereby established, under the supervision of the Department of Education, a
3 national science high school in Barangay Dos, Las Piñas City to be known as
4 the Las Piñas City National Science High School.

5 SEC. 2. *Appropriations.* – The Secretary of Education shall
6 immediately include in the Department's program the operationalization of the
7 Las Piñas City National Science High School, the funding of which shall be
8 included in the annual General Appropriations Act.

1 SEC. 3. *Implementation.* – The Secretary of Education shall issue such
2 rules and regulations as may be necessary to carry out the purpose of this Act.

3 SEC. 4. *Effectivity.* – This Act shall take effect fifteen (15) days after
4 its publication in the *Official Gazette*.
