





No. 104

AN ACT PROVIDING FOR THE REAPPORTIONMENT OF THE
LONE LEGISLATIVE DISTRICT OF THE PROVINCE OF
AGUSAN DEL SUR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Legislative Districts.* – The lone legislative district of the
2 Province of Agusan del Sur is hereby reapportioned to commence in the next
3 national elections after the effectivity of this Act. Henceforth, the City of
4 Bayugan and the municipalities of Sibagat, Prosperidad, Talacogon, San Luis
5 and Esperanza shall comprise the first legislative district while the
6 municipalities of San Francisco, Rosario, Bunawan, Trento, Sta. Josefa,
7 Veruela, Loreto and La Paz shall comprise the second legislative district.

8 SEC. 2. *Rules and Regulations.* – The Commission on Elections shall
9 issue the necessary rules and regulations to implement this Act.

10 SEC. 3. *Repealing Clause.* – All other laws, rules and regulations
11 inconsistent with this Act are hereby repealed, amended or modified
12 accordingly.

13 SEC. 4. *Effectivity.* – This Act shall take effect fifteen (15) days after
14 its publication in at least two (2) newspapers of general circulation.
