EXPLANATORY NOTE

Despite the resolute plans and programs, the intended acceleration of the development of the local dairy industry has never materialized since the inception of the National Dairy Authority in 1995 by virtue of Republic Act (RA) No. 7884. This Dairy Law is never fully funded and thus has severely hampered the development efforts of the Authority.

The Authority has struggled and made use of its very limited resources to move the local dairy industry, which resulted in very modest gains as manifested by the growing enthusiasm to go to dairy by the farmer sector, the cooperative sector, the local government sector and the non-government sector. Likewise, local consumers are now aware and appreciative of the health and economic contribution of having local milk on their tables, especially in the rural areas and in selected urban areas where local milk has been an important ingredient of well-known coffee brands/chain shops.

The Authority however, is constrained to institute milk safety measures directly on milk product imports because it does not have any regulatory power. At present, the regulation of milk products rests on the combined efforts of the Bureau of Animal Industry (BAI) for issuance of import permit clearance, the Bureau of Agriculture & Fishery Product Standards (BAFPS) for fresh milk product standardization, the Bureau of Food and Drugs (BFAD) for registration, labeling and testing of processed milk products and the Department of Trade (DTI) for the monitoring of prices of milk products.

We do not want, and we must never opt, another milk scare in our midst, where a significant number of children died in China due to melamine contamination, an obvious lapse in the observance of milk safety protocols.

It is hoped that this legislation shall be instrumental in gearing up the Authority to act potently in steering the local dairy industry to the road to progress. Producing and buying local milk means rural development, and rural development means economic progress, and economic progress means a stable nation.

Immediate approval of this Act is thus earnestly sought.

AN ACT AMENDING REPUBLIC ACT NUMBERED 7884, OTHERWISE KNOWN AS THE "NATIONAL DAIRY DEVELOPMENT ACT OF 1995"

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. Sections 5, 6, 14, 16, 18 and 22 of Republic Act No. 7884 are
- 2 hereby amended to read as follows:
- 3 "Sec. 5. The Dairy Industry Board. The National Dairy Authority shall
- 4 be governed by a Dairy Industry Board, hereafter referred to as the "Board", to
- 5 be composed of the following:
- 6 (a) The Secretary of Agriculture, as chairperson;
- 7 (b) The NDA Administrator, as an ex officio member;
- 8 (c) The Secretary of Trade and Industry, as member;
- 9 (d) The Secretary of Health, as member;
- (e) The Secretary of Education, Culture and Sports, as member;
- (f) The Secretary of Science and Technology, as member;
- (g) The Secretary of Agrarian Reform, as member;
- 13 (h) The {Director of the Dairy Training and Research Institute, as
- member] SECRETARY OF THE DEPARTMENT OF SOCIAL WELFARE
- 15 AND DEVELOPMENT, as member; and

(i) Four (4) other members who shall be appointed by the President of 1 the Philippines upon the recommendation of the chairperson: Provided, That 2 one (1) shall come from the COMMERCIAL MILK PROCESSOR'S GROUP 3 AND THE OTHER THREE (3) FROM THE dairy cooperatives and/or 4 national dairy federation, with one representative each from Luzon, Visayas 5 and Mindanao: Provided, further, That they will hold office for a period of 6 three (3) years from the date of their respective appointments without 7 reappointment; Provided, finally, That any member appointed to a vacancy 8 shall serve only for the unexpired term of the member whom he succeeds. 9

10 THE BOARD, AS THE GOVERNING AND POLICY
11 DETERMINING BODY OF THE AUTHORITY, SHALL HAVE, AMONG
12 OTHERS, THE POWER TO:

(A) CREATE RELEVANT ORGANIZATIONAL UNITS ALONG WITH THE REQUIRED MANPOWER RESOURCES AND LOGISTICS SUPPORT SO AS TO RESPOND TO THE DEMAND OF THE INDUSTRY;

- (B) REVIEW AND REORGANIZE THE AUTHORITY SO AS TO MAINTAIN EQUAL REPRESENTATION FROM THE GOVERNMENT AND THE PRIVATE SECTOR;
- (C) DESIGN AND IMPLEMENT PERSONNEL DEVELOPMENT
 AND COMPENSATION PACKAGES, PROVIDED THAT THE
 AUTHORITY HAS SUFFICIENT FUNDING TO DO SO COMING FROM
 ITS REVENUE GENERATING ACTIVITIES OR OPERATIONS;
- (D) ENACT SOUND AND REASONABLE POLICIES FOR THE 23 **AUTHORITY** ENGAGE IN **DAIRY** RELATED TO **BUSINESS** 24 LIKE PRODUCTION, PROCESSING, PACKAGING, **ACTIVITIES,** 25 DISTRIBUTION, PROMOTION, TRADING, BUSINESS CONSULTING 26 AND MANAGEMENT SERVICES; PROVIDED THAT THE ANNUAL 27 NET INCOME GENERATED FROM SUCH ACTIVITIES DOES NOT 28 EXCEED TEN PERCENT (10%) OF THE COMBINED TOTAL DAIRY 29 PRODUCTS SOLD IN THE MARKET BY DAIRY COOPERATIVES, 30 COMMERCIAL MILK PROCESSORS, DAIRY IMPORTERS AND 31 TRADERS BASED ON THEIR LATEST ANNUAL SALES RECORD, OR 32 TEN PERCENT (10%) OF THE VALUE OF THE LAST YEAR'S TOTAL 33 DAIRY IMPORTS MADE, WHICHEVER IS HIGHER; AND 34

(E) ESTABLISH SUBSIDIARIES OR INVEST IN PRIVATE
CORPORATIONS, WHENEVER REASONABLY NECESSARY AND
APPROPRIATE, PURPOSELY TO AUGMENT OR SUPPLEMENT THE
OPERATIONS OF THE AUTHORITY PROVIDED THAT ITS TOTAL
EXPOSURE DOES NOT EXCEED TWENTY FIVE PERCENT (25%) OF THE
AUTHORITY'S CURRENT NET EQUITY."

- "Sec. 6. Powers and Functions of the National Dairy Authority. The National Dairy Authority shall have the following powers and functions:
- (a) To formulate and execute dairy programs that will generate a national impact on rural as well as urban nutrition levels and incomes;
- (b) To assist in the purchase, importation, propagation, storage, distribution and sale of dairy equipment and engineering supplies and such other inputs as may be needed by the dairy industry;
- (c) To encourage the integration of dairy production and local milk and the distribution of dairy products into various rural livelihood and nutrition programs;
- (d) To assume control and supervision over all dairy-related government agency personnel and programs, including the Bureau of Animal Industry's Dairy Division, the Livestock Development Council's Dairy Division, the Philippine Dairy Corporation, Livelihood Corporation's Laguna Processing Center and other dairy related government agencies, division, councils subject to the guidelines prescribed by the Civil Service Commission;
- (e) To borrow, raise or obtain funds; to issue bonds and other instruments of indebtedness; or to enter into any financial or credit arrangement in order to support or carry out its objectives and purposes, subject to pertinent laws governing public debts and expenditures;
- (f) To receive grants, subsidies, donations or contributions from corporations, thrusts, foundations, associations and other sources from any private or government office, agency or corporation in the Philippines or abroad;
- (g) To establish, maintain or operate field units or offices in various parts of the country in order to utilize the objectives of this Act;
- (h) To help design and implement a credit system that will finance dairy farmers and dairy cooperatives or associations;

- (i) To charge reasonable fees for services rendered for the attainment of 1 the objectives of this Act; 2
- (j) To promulgate rules and regulations to carry out the provisions and 3 policy objectives of this Act; [and] 4
- (k) To adopt, alter and use a corporate seal; to sue and be sued; and 5 otherwise to do and perform all acts or exercise all powers as may be necessary or incidental to carry out the objectives of this Act[.]; 7

- (L) TO SET UP A ONE STOP SHOP INSPECTION AND 8 SURVEILLANCE CENTER TO BE NAMED AS THE DAIRY INSPECTION 9 AND SURVEILLANCE CENTER (DISC) AND ENLIST THE ASSISTANCE 10 FOR SUCH PURPOSE OF THE MILK AND DAIRY INSTITUTE OF THE 11 PHILIPPINE (MDIP), BUREAU OF AGRICULTURAL & FISHERIES 12 PRODUCT STANDARDS (BAFPS), BUREAU OF FOOD & DRUGS 13 (BFAD), FOOD DEVELOPMENT CENTER (FDC), FOOD & NUTRITION 14 RESEARCH INSTITUTE (FNRI), PHILIPPINE NUCLEAR RESEARCH 15 INSTITUTE (PNRI), NATIONAL CONSUMERS WELFARE GROUP AND 16 OTHER LOCAL OR FOREIGN ENTITIES; 17
- (M) TO MONITOR, ON THE BASIS OF EXISTING SUBSTANTIVE 18 EVIDENCE, ENTITY, NATURAL OR JURIDICAL, ENGAGED IN ANY 19 DAIRY PRODUCTION AND MARKETING MALPRACTICE 20 DEFINED HEREUNDER AND, FOR THE SAID PURPOSE, CALL UPON 21 THE BUREAU OF CUSTOMS (BOC), THE PHILIPPINE PORTS 22 AUTHORITY (PPA), THE PHILIPPINE COAST GUARD (PCG), THE 23 PHILIPPINE NATIONAL POLICE (PNP), THE NATIONAL BUREAU OF 24 INVESTIGATION (NBI) AND OTHER LAW ENFORCEMENT AGENCIES 25 OF GOVERNMENT TO CONDUCT INTELLIGENCE AND COUNTER-26 INTELLIGENCE OPERATIONS; 27
- FOR PURPOSES OF THIS PROVISION, **DAIRY** 28 PRODUCTION AND MARKETING **MALPRACTICES** SHALL 29 CONSIST OF ANY OF THE FOLLOWING: A) UNHYGIENIC FARM 30 AND PLANT PRACTICES WHICH TEND TO CONTAMINATE MILK 31 AND MILK PRODUCTS; B) ADULTERATION OF RAW MILK BY 32 ADDING WATER; C) UNCLEAN HAND MILKING WHICH TEND 33 TO CAUSE MASTITIS AND THUS CONTAMINATE MILK; D) 34 DUMPING OF IMPORTED MILK PRODUCTS; E) UNDECLARED 35 STOCKING OR INVENTORY, BUFFERING OR HOARDING; F) 36

1 UNFOUNDED PRICE HIKING; AND G) MISLABELING, AND
2 OTHERS THAT MAYBE IDENTIFIED IN THE IMPLEMENTING
3 RULES & REGULATIONS (IRR);

(N) TO CONDUCT REGULAR VISITS OR, IF NECESSARY, DO
5 SPOT INSPECTIONS OF DAIRY FACILITIES SUCH AS BUT NOT
6 LIMITED TO LABORATORIES, PLANTS, MARKET OUTLETS AND
7 WAREHOUSES; AND

(O) TO REQUIRE OR ENJOIN ALL SECTORS INVOLVED IN DAIRY RELATED BUSINESSES TO SUBMIT REGULARLY RELEVANT REPORTS, ACTUAL AND PLANNED, SUCH AS, BUT NOT LIMITED TO, PRODUCTION, INVENTORY, DISTRIBUTION, MARKET, SALES, PRICING AND COSTS."

14 "Sec. 14. Dairy Development Fund. - To implement [Section 13] THE **PROVISIONS** of this Act, there is hereby created a Dairy Development Fund 15 which shall be used exclusively for the [above-mentioned] programs, 16 PROJECTS AND ADDITIONAL FUNCTIONS AND DUTIES OF THE 17 AUTHORITY AS PROVIDED FOR IN THIS ACT in the amount of Two 18 pesos (P200,000,000)] **FIVE** BILLION 19 million (P5,000,000,000.00) from the funds in the National Treasury not otherwise 20 appropriated FOR A PERIOD OF FIVE (5) YEARS. [Annually thereafter, the 21 amount of not less than One hundred forty million pesos (P140,000,000) shall 22 be provided to augment the fund in the General Appropriations Act.] THE 23 INITIAL RELEASE SHALL BE MADE UPON THE EFFECTIVITY OF THIS 24 ACT WHICH SHALL NOT BE LESS THAN ONE BILLION PESOS 25 (P1,000,000,000.00). IN ORDER TO REALIZE THIS FUNDING THERE 26 OTHERS, AN **SHALL** AMONG **AUTOMATIC** BUDGET 27 ALLOCATION EQUIVALENT TO TWENTY-FIVE (25%) PERCENT OF 28 THE ANNUAL VALUE-ADDED TAX COLLECTIONS FROM THE SALE 29 OF LOCAL AND IMPORTED DAIRY PRODUCTS, RAW MATERIALS, 30 DAIRY EQUIPMENT AND OTHER DAIRY RELATED PRODUCTS." 31

"Sec. 16. Nutrition Programs. — [The government's] ALL nutrition programs requiring milk and dairy products shall be PRIMARILY sourced from small farmers [and], dairy cooperatives AND LOCAL PRIVATE

- PRODUCERS AS DULY CERTIFIED BY [in coordination with] the
 Authority."
- "Sec. 18. Exemption from Taxes and Duties. The authority shall be exempt from the payment of customs duties and taxes on the importation of dairy animals, veterinary and other supplies, other farm inputs, dairy equipment and machineries, including its spare parts, for distribution to dairy cooperatives subject to the following conditions:
- 8 (1) That said equipment and machineries, including its spare parts are 9 not manufactured domestically in sufficient quantity, of comparable quality 10 and reasonable prices;
 - (2) That it shall be actually, directly and exclusively used by the dairy cooperatives in the manufacture of its products;

- (3) That it shall not be disposed within three (3) years from acquisition, without prior approval of the Authority; and
- (4) If it will be subsequently sold, transferred or exchanged in the Philippines to non-exempt persons or entities, the purchasers or recipients shall be considered the importers thereof, and shall be liable for the customs duties and internal revenue taxes due on such importations. The customs duties and internal revenue taxes due on such articles shall constitute a lien on the article itself, superior to all other charges or liens, irrespective of the possessors thereof.
- Any donation, contribution, bequest, subsidy or financial aid which may be made to the Authority shall constitute as allowable deduction from the income of the donor for income tax purposes and shall be exempt from donor's tax, subject to such conditions as provided under the National Internal Revenue Code, as amended.
- Small farmers and small farmers' dairy cooperatives shall be exempt from all taxes on proceeds from sale of raw milk and milk products.

Milk processors shall enjoy a presumptive input tax credit of four percent (4%) of the value of their gross purchases from small farmers and small farmers' dairy cooperatives.

Penalty Clause. - Any person or entity found guilty of violating any provision of this Act, shall be sentenced to an imprisonment of 19 not more than six (6) months or a fine of [not more than Twenty thousand 20 pesos (P20,000.00) or both upon the discretion of the Court ONE MILLION 21 PESOS (P1,000,000.00) FOR THE FIRST OFFENSE, TWO MILLION PESOS 22 (P2,000,000.00) FOR THE SECOND OFFENSE AND THREE MILLION 23 PESOS (P3,000,000.00) AND THE REVOCATION OR CANCELLATION OF 24 ALL PERTINENT LICENSES OR PERMITS FOR THE THIRD OFFENSE." 25

SEC. 2. Implementing Rules and Regulations. To effectively implement the provisions of this Act, the Authority, in coordination with the concerned agencies of government as well as the private sector, shall promulgate the required implementing rules and regulations.

SEC. 3. Separability Clause. If any provision or part hereof is held invalid or unconstitutional, the remainder of the law or the provision not otherwise

affected shall remain valid and subsisting.

- 1 SEC. 4. Repealing Clause. All laws, presidential decrees, executive
- 2 orders, proclamations and/or administrative regulations which are
- 3 inconsistent with the provisions of this Act are hereby amended, modified,
- 4 superseded or repealed accordingly.

- 6 SEC. 5. Effectivity Clause. This Act shall take effect fifteen (15) days
- 7 from its publication in at least two newspapers of national circulation.
