EXPLANATORY NOTE

The power of the State to impose civil pecuniary penalties for violation of the penal law has a deterrent effect. But inflation has weakened this deterrent effect.

Thus, the government needs to provide for the assessment and adjustment of existing values of the civil monetary penalties. This bill provides for the regular adjustment for inflation of civil monetary penalties, and maintain their deterrent effect.

This bill is a product of the public hearings conducted by the Committee on Constitutional Amendments, Revision of Codes and Laws during the 13th Congress.*

Introduced by Senator Miriam Defensor Santiago 1 AN ACT 2 PROVIDING THE PROCEDURE FOR THE REGULAR ADJUSTMENT FOR INFLATION OF CIVIL MONETARY PENALTIES AS PROVIDED IN THE PENAL CODE AND 4 AMOUNT OF DAMAGES CAUSED BY A CRIME OR QUASI-DELICT Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled: 5 SECTION 1. Short Title. - This Act shall be known as the "Civil Penalties and Damages 6 Inflation Adjustment Act." 7 SECTION 2. Declaration of Policy. - It is hereby declared the policy of the State to maintain the deterrent nature of its penal laws, more specifically, the civil monetary penalties and 8 9 damages for death caused by a crime or quasi-delict by adjusting its amounts regularly in 10 accordance with prevailing inflation rates. 11 SECTION 3. Definition of Terms. -12 (A) "Civil Penalty" means any penalty, fine, or other sanction that -(1) Is for a specific monetary amount as provided by the Penal Code; or 13 (2) Has a minimum and/or maximum amount provided by the Penal Code; or 14 (3) Is assessed or enforced by the courts pursuant to the Penal Code; and 15 (B) "Damages" means damages for death caused by crime or quasi-delict as provided in 16 the Civil Code; Article 2206 17 (C) "Consumer Price Index" means the Consumer Price Index for all urban consumers 18

1	(D) "Cost-of-Living Adjustment" means the percentage, if any, for each civil monetary
2	penalty and damages by which the Consumer Price Index for the month of June of the
3	calendar year preceding the adjustment, exceeds the Consumer Price Index for the
4	month of June of the calendar year in which the amount of such civil monetary was
5	last set or adjusted pursuant to law.
6	(E) "Secretary" shall refer to the Secretary of the Department of Justice.
7	SECTION 4. Civil Monetary Penalty Inflation Adjustment Reports Within six (6)
8	months after the date of enactment of this Act, and on the first week of January of each fifth
9	calendar year thereafter, the Secretary shall submit a report on civil monetary penalty inflation
10	and damages adjustment to both Houses of Congress. Such report shall include:
11	(A) Each civil monetary penalty and damages as defined under Section 3(A);
12	(B) The date each civil monetary and damages was not recently set pursuant to law;
13	(C) The maximum amount of each civil monetary penalty and damages or, if applicable,
14	the range of the minimum and maximum amounts of each civil monetary penalty and
15	damages in effect on the date of submission of each report;
16	(D) The amount of each civil monetary penalty and damages prescribed under paragraph
17	(C) other than any such penalty for which inflation adjustment is provided by law, if
18	each such penalty is increased by the adjustment described under Section 3(C) of this
19	Act; and
20	(E) A listing of the modifications to the Penal Code that would require to:
21	(1) Increase each penalty described in paragraph (A) by the adjustment described
22	under Section 3(C), excluding any penalty for which inflation adjustment is
23	provided by law or that has been increased within the five (5) year period
24	immediately preceding the date of submission of such report; and
25	(2) Provide that any increase in any civil monetary penalty and damages shall

apply only to violations which occur after the date any such increase takes.

1	SECTION 5. Cost-of-Living Adjustments of Civil Monetary Penalties. –
2	(A) Adjustment The Adjustment described under Section 4, paragraph (D) and (E)(1)
3	shall be determined by increasing the maximum civil monetary penalty and damages or the range
4	of minimum and maximum civil monetary penalties and damages, as applicable, for each civil
5	monetary penalty and damages by the cost-of-living adjustment. Any increase determined under
6	this subsection shall be rounded to the nearest:
7	(1) Multiple of Ten Pesos (P10.00) in the case of penalties less than or equal to
8	One Hundred Pesos (P100.00);
9	(2) Multiple of One Hundred Pesos (P100.00) in the case of penalties greater than
10	One Hundred Pesos (P100.00) but less than or equal to One Thousand Pesos
11	(P1,000.00);
12	(3) Multiple of One Thousand pesos (P1,000.00) in the case of penalties greater
13	than One Thousand Pesos (P1,000.00) but less than or equal to Ten Thousand
14	Pesos (P10,000.00);
15	(4) Multiple of Five Thousand Pesos (P5,000.00) in the case of penalties greater
16	than Ten Thousand Pesos (P10,000.00) but less than or equal to One Hundred
17	Thousand Pesos (P100,000.00);
18	(5) Multiple of Ten Thousand Pesos (P10,000.00) in the case of penalties greater
19	than One Hundred Thousand Pesos (P100,000.00) but less than or equal to
20	Two Hundred Thousand Pesos (P200,000.00); and
21	(6) Multiple of Twenty Five Thousand Pesos (P25,000.00) in the case of penalties
22	greater than Two Hundred Thousand Pesos (P200,000.00).
23	SECTION 6. Annual Report No later than first week January of each year, the
24	Secretary in consultation with the National Economic and Development Authority (NEDA) and
25	he National Statistics Office (NSO) shall submit a report on civil monetary penalties to the
26	Congress which shall include:
27	(A) To the extent possible, the number and amount of civil monetary penalties and
28	damages imposed pursuant to each provision of law providing for such civil

1	monetary penalties and damages, during the complete fiscal year preceding the
2	submission of such report;
3	(B) To the extent possible, the number and amount of such civil penalties and damages
4	collected during such fiscal year; and
5	(C) Any recommendation that the Secretary determines appropriate to:
6	(1) Eliminate obsolete civil monetary penalties and damages;
7	(2) Modify the amount of any civil monetary and damages;
8	(3) Make any other legislative modifications concerning civil monetary penalties
9	and damages.
10	SECTION 7. Congressional Action The Chairpersons of the Senate Committee on
11	Constitutional Amendments, Revision of Codes and Laws, and the House of Representatives'
12	Committee on Revision of Codes and Laws shall, upon receipt of the annual report, file the
13	necessary bill to amend the present laws affected by the report with the respective houses. The
14	bill shall be immediately forwarded to the Senate President and the Speaker of the House of
15	Representatives for certification as urgent.
16	SECTION 8. Separability Clause If any provision or part hereof is held invalid or
17	unconstitutional, the remainder of the law or the provision not otherwise affected shall remain
18	valid and subsisting.
19	SECTION 9. Repealing Clause Any law, presidential decree or issuance, executive
20	order, letter of instruction, administrative order, rules or regulations or part thereof, contrary to or
21	inconsistent with the provision of this Act is hereby repealed, modified, or amended accordingly.
22	SECTION 10. Effectivity Clause This Act shall take effect fifteen (15) days after its
23	publication in at least two (2) newspapers of general circulation.
