EXPLANATORY NOTE

A pet is an animal kept for companionship and enjoyment or a household animal, as opposed to livestock, laboratory animals, working animals or sport animals, which are kept for economic reasons. Pets however, provide their owners with other benefits: to relieve stress, provide companionship and security. In fact, there is now a medically-approved class of "therapy animals," mostly dogs that are brought to visit confined humans. A recent study concluded that owning a pet can reduce the risk of a heart attack by 2% and that pets are better than medication in reducing blood pressure. Pets have the ability to stimulate their caregivers, in particular the elderly, giving people someone to take care of, someone to exercise with, and someone to help them heal from a physically or psychologically troubled past. Finally, caring for pets teaches children how to be responsible and gentle with beings that are weaker than them.

Many households have pets. In the U.S., around 63 percent of all households (71.1 million) are pet owners. In the Philippines many households have more than one animal. Unfortunately, despite the love for their pets, many owners have been lax, and sometimes negligent, in the care of their animals. Many owners are working individuals who have little time to take their pets to the veterinarians for regular check-ups.

This Act aims to create a special non-working holiday to increase public awareness of the concept of pet care, ensure meaningful observance of the same, allow pet owners the opportunity to take their pets for a check-up, and encourage participation in activities that are to be spearheaded by the Bureau of Animal Industry of the Department of Agriculture and the various government offices concerned.

Francis of Assisi is honored by the Catholic Church as the patron saint of animals and ecology. Every year on the Sunday nearest his October 4 feast day, Catholic and other Christian churches around the world host services where animals are blessed. These services celebrate Francis's compassionate concern for all creatures. It is proposed that National Pet day be celebrated every 4th of October.1

	Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:
4	SECTION 1. Short Title This Act shall be known as the "National Pet Day
5	Act."
6	SECTION 2. Special Non-Working Holiday In recognition of the need to
7	establish a comprehensive national consciousness of pet care, the fourth day of October is
8	hereby declared as a special non-working holiday to be known as "National Pet Day".
9	SECTION 3. Activities that shall be undertaken in observance of this occasion. –
10	(a) The Philippine Information Agency shall be mandated to allocate a minimum
11	of one (1) hour airtime for programs exclusively raising public awareness of pet care,

(b) The Bureau of Animal Industry of the Dept. of Agriculture, the Department of Education, the Commission on Higher Education, shall lead public and private school communities at all levels in organizing consciousness-raising activities on pet care, animal welfare and animal rights human rights. Their activities shall be in coordination with nongovernmental organizations (NGOs) and advocates for animal welfare including the following:

1	a. Philippine Society for the Prevention of Cruelty to Animals (PSPCA);
2	b. Philippine Animal Welfare Society (PAWS);
3	c. Protected Areas and Wildlife Bureau (PAWB) of the Department of
