# 2 RECOGNIZING BUSINESSES WHICH SHOW AN EXEMPLARY COMMITMENT TO 3 PARTICIPATING WITH SCHOOLS TO ENHANCE EDUCATORS' TECHNOLOGY 4 CAPABILITIES AND TO MAKE EVERY STUDENT TECHNOLOGICALLY LITERATE

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

5 SECTION 1. Short Title. – This Act shall be known as the "Business and Education

6 Sharing Technology Act (BEST)."

7 SECTION 2. *Purpose*. - It is the purpose of this Act –

8 (A) To establish a program to give local and national recognition to businesses which 9 show an exemplary commitment to participating with schools to make every student 10 technologically literate; and

11 (B) To make information about these exemplary partnerships available to other 12 businesses and schools.

13 SECTION 3. *Nomination.* - The Department of Education shall form a committee 14 composed of qualified individuals, such as representatives from the government, academe, 15 private sector and appropriate sectors to carry out the provisions of this Act. The members shall 16 select, through a competitive process, the businesses engaged in technology partnerships with 17 schools to receive a BEST award.

18 Representatives of any educational institutions or schools may nominate businesses 19 which show an exemplary commitment to participating with schools to enhance educators'

- 1 technology capabilities and to make every student technologically literate. Such nominations
- 2 shall, if available, include:
- 3 (A) Name of business;
- 4 (B) Address of business;
- 5 (C) Internet address of business;
- 6 (D) A description of the partnership between school or school district and the business,
- 7 including the specific services provided by the business to the school;
- 8 (E) A description of how the partnership is helping to enhance the technological 9 capabilities of educators *or* to make every student technologically literate; and
- 10 (F) A description of why the partnership is exemplary.
- 11 SECTION 4. Criteria. -To be eligible to receive a BEST recognition award –
- 12 (A) A business must be in active partnership with a school, consortium of schools, or
- 13 local educational agency;
- (B) The purpose of the partnership must be to enhance educators' technology capabilities
  and contribute to making every student technology literate;
- 16 (C) The partnership must have a plan to enhance educators' technology capabilities or 17 contribute to making every student technologically literate which can he shared with other 18 schools; and
- 19 (D) The partnership activities must he of a high level of quality.
- 20 SECTION 5. *Dissemination*. The Department of Education shall issue the necessary 21 rules and regulations in implementing this Act and shall make information and descriptions 22 regarding the programs and partnerships that are chosen for a BEST recognition award available 23 to schools nationwide.

SECTION 6. Separability Clause. - If any provision or part hereof, is held invalid or
 unconstitutional, the remainder of the law or provision not otherwise affected shall remain valid
 and subsisting.

4 SECTION 7. *Repealing Clause.* - Any law, presidential decree or issuance, executive 5 order, letter of instruction, administrative order, rule or regulation contrary to or inconsistent 6 with the provision of this Act is hereby repealed, modified or amended accordingly.

SECTION 8. *Effectivity Clause.* - This Act shall take effect fifteen (15) days after its
publication in at least two (2) newspapers of general circulation.
