EXPLANATORY NOTE

Introduced by Senator Miriam Defensor Santiago

The Civil Code, Article 737, states "the donor's capacity shall be determined as of the time of the making of the donation." The term "making must be interpreted to mean "perfection" of the donation, otherwise if "making" means "giving," Article 737 would in some cases be inconsistent with Article 734 which states that "the donation is perfected from the moment the donor knows of the acceptance by the donee."

An example of the perceived inconsistency is: "an insane donor donates on January 1. Donoe accepts on January 5. Donor regains sanity on January 7. Donor knows of donee's acceptance on January 8, at a time when he was sane (capacitated). In this case, if we interpret "making" as "giving," the donation would be avoidable because of the donor's incapacity at the time he "gave" his property to the donee. On the other hand, if we consider "making" as "perfection," the donation would be valid because at the time of "making" (perfection), both parties had full capacity."

To avoid this contradiction, the language of Article 737 must be changed to make it clear and consistent with other provisions of the Civil Code on Donations.*
