EXPLANATORY NOTE

Republic Act No. 7160, also known as the Local Government Code of 1991, Section 40(d) provides that a person with dual citizenship is disqualified from running for any elective local position. However, the Supreme Gourt in the case of *Mercado v. Manzano*, 307 SCRA 630 (1999), stated that Section 40(d) should be understood to mean dual allegiance and not dual citizenship.

Said the Supreme Court:

"Clearly, in including § 5 in Article IV on citizenship, the concern of the Constitutional Commission was not with dual citizens per se but with naturalized citizens who maintain their allegiance to their countries of origin even after their naturalization. Hence, the phrase "dual citizenship" in R.A. No. 7160, Section 40(d) and in R.A. No. 7854, Section 20 must be understood as referring to "dual allegiance."

Consequently, persons with mere dual citizenship do not fall under this disqualification. Unlike those with dual allegiance, who must, therefore, be subject to strict process with respect to the termination of their status, for candidates with dual citizenship, it should suffice if, upon the filing of their certificates of candidacy, they elect Philippine citizenship to terminate their status as persons with dual citizenship considering that their condition is the unavoidable consequence of conflicting laws of different states." (Emphasis supplied)

This bill aims to correct the oversight in the drafting of Section 40(d) of R.A. No. 7160, in order to make Section 40 (d) conform to the Constitution and the ruling of the Supreme Court in the case mentioned above.¹

- 4 SECTION 3. Effectivity Clause. This Act shall take effect fifteen (15) days after its
- 5 publication in at least two (2) newspapers of general circulation.
