EXPLANATORY NOTE

This bill seeks to legislate the period of probationary employment for professors, instructors, and teachers, and other academic personnel in private educational institutions.

It is a declared policy of the State to recognize the complementary roles of public and private institutions in the educational system. Consistent with this, the State shall exercise reasonable supervision and regulation of all educational institutions and likewise enhance the right of teachers to professional advancement. The State shall further ensure that teaching will attract and retain its rightful share of the best available talents through adequate remuneration and other means of job satisfaction and fulfillment. (Art. XIV, Sec. 4(1), Sec. 5(4) and 5(5), 1987 Constitution)

In furtherance of these declarations, there is a need to shorten the probationary employment for teachers, instructors, and professors and other academic personnel in private schools from the existing three-year period to just a year of very satisfactory service for those in the elementary and secondary levels, from six down to two consecutive regular semesters of very satisfactory service for in the tertiary level, and from nine to three consecutive trimesters of very satisfactory service for those in the tertiary level where collegiate courses are offered on the trimester basis. This measure will ensure that private schools get the best available talents and employ them as regular employees at the shortest time possible, while simultaneously affording to the academic personnel their right to professional advancement.

regulations or parts thereof, which are inconsistent with this Act, are hereby repealed, amended
or modified accordingly.
SECTION 3. This Act shall take effect fifteen (15) days after its complete
publication in the Official Gazette or in at least two (2) newspapers of general circulation,
