EXPLANATORY NOTE

This bill seeks to declare the El Nido-Taytay Managed Resource Protected Area (ENTMRPA) in Palawan as a protected area.

The ENTMRPA, which covers 89,134.76 hectares, serves as a sanctuary to diverse terrestrial and marine life species. Found in the area are 16 bird species, nine of which are considered common, five uncommon and 1 vulnerable. Also, the ENTMRPA serves as a habitat for six species of large terrestrial mammals limited to the Philippines. Three main habitat types in the area include terrestrial forest, littoral zone and marine habitats.

Recognizing the value of the area, it was established as El Nido-Taytay Managed Resource Protected Area by virtue of Presidential Proclamation No. 32, dated October 8, 1998.

This bill, therefore, seeks to declare the El Nido-Taytay Managed Resource Protected Area as a protected area in order to protect it from indiscriminate exploitation and to be able to maintain its ecological balance.

Given the importance of biodiversity, it is deemed crucial that we act on these now to ensure that our children and the succeeding generations will inherit a living earth with all of its bountiful natural resources and vibrant wildlife.

In view of the foregoing, the passage of this measure is earnestly urged.

AN ACT ESTABLISHING THE EL-NIDO-TAYTAY MANAGED RESOURCE PROTECTED AREA LOCATED IN THE MUNICAPALITIES OF EL NIDO AND TAYTAY, PROVINCE OF PALAWAN, AS A PROTECTED AREA UNDER THE CATEGORY OF PROTECTED LANDSCAPE PROVIDING FOR ITS MANAGEMENT-AND FOR OTHER PURPOSES

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

Section 1. Title. - This Act shall be known as the El Nido-Taytay Managed Resource Protected Area (ENTMRPA) Act of 2010"

- Sec. 2. Land Classification. All lands of the public domain comprising the El Nido-Taytay Managed Resource Protected Area (ENTMRPA) shall fall under the classification of National Park as provided for in the Philippine Constitution.
- Sec. 3. *Definition of Terms.* The following terms are hereby defined for the purpose of this Act:
- a. "Ancestral Domain" refers to all lands and natural resources occupied or possessed by indigenous cultural communities, by themselves or through their ancestors, communally or individually, in accordance with their customs and traditions since time immemorial, continuously to the present except when interrupted by war, force majeure, or displacement by force, deceit or stealth. It includes all adjacent areas generally belonging to them and which are necessary to ensure their economic, social and cultural welfare.
- b. "Biodiversity" refers to variety and variability among living organisms and the ecological complexes in which said organisms occur.
- c. "Biological resources" includes genetic resources, organisms or parts thereof, population, or any other biotic component of ecosystems with actual or potential use or value for humanity.

- e. "Buffer Zone" is the identified area outside the boundaries of and immediately adjacent to designated ENTMRPA that need special development control in order to avoid or minimize harm to the protected area.
- f. "By-product or derivatives" means any part taken or substance extracted from wildlife, in raw or in processed form. This includes stuffed animals and herbarium specimens.
- g. "Collection or collecting" is the act of gathering or harvesting wildlife, its byproducts or derivatives.
- h. "Conservation" means preservation and sustainable utilization of wildlife, and/or maintenance, restoration and enhancement of the habitat.
- i. "Endangered species" refers to species or subspecies of flora and fauna that is not critically endangered but whose survival in the wild is unlikely if the causal factors continue operating.
- j. "Endemic species" means species or subspecies of flora and fauna which is naturally occurring and found only within specific areas in the country.
- k. "Exotic species" means species or subspecies of flora and fauna which do not naturally occur within the protected area at present or in historical time.
- I. "Habitat" means a place or type of environment where a species or subspecies naturally occurs or has naturally established its population.
- m. "Hunting" refers to collection of wild fauna for food and/or recreational purposes with the use of weapons such as guns, bow and arrow, spear and the like;
- n. "Indigenous Cultural Communities" refers to tribes, including but not limited to Tagbanuas, who have continuously lived as communities on communally bounded and defined land since time immemorial and have succeeded in preserving, maintaining, and sharing common bonds of language, customs, traditions and other distinctive cultural traits.
- o. "Indigenous Cultural Communities or Indigenous People (ICC/ IPs)" refers to a group of people or homogenous societies identified by self-ascription and ascription by others, who have continuously lived as organized community on communally bounded and defined territory, and who have, under claims of ownership since time immemorial, occupied, possessed and utilized such territories, sharing common bonds of language, customs, traditions and other distinctive cultural traits, or who have, through resistance to political, social and cultural inroads of colonization, non-indigenous religions and cultures, became historically differentiated from the majority of Filipinos. IPs shall likewise include peoples who are regarded as indigenous on

account of their descent from the populations which inhabited the Country, at the time of conquest or colonization, or at the time of inroads of non-indigenous religions and cultures, or the establishment of present state boundaries, who retain some or all of their own social, economic, cultural and political institutions, but who may have been displaced from their traditional domains or who may have resettled outside their ancestral domains.

- p. "Management plan" refers to the fundamental plan, strategy and/or scheme which shall guide all activities relating to the ENTMRPA in order to attain the objectives of this Act.
- q. "Mineral" refers to all naturally occurring inorganic substance in solid, gas, liquid, or any intermediate state including energy materials such as coal, petroleum, natural gas, radioactive materials, and geothermal energy.
- r. "Multiple-Use Zone" refers to an area where settlement, traditional and/or sustainable land use, including agriculture, agro-forestry, extraction activities and other income generating or livelihood activities, may be allowed to the extent prescribed in the IPAP/PAMP.
 - s. "National Integrated Protected Areas System" is the classification and administration of all designated protected areas to maintain essential ecological processes and life-support systems, to preserve genetic diversity, to ensure sustainable use of resources found therein, and to maintain their natural conditions to the greatest extent possible.
- t. "National Park" refers to the land of the public domain classified as such in the 1987 Constitution which include all areas under the National Integrated Protected Areas System (NIPAS) pursuant to R.A. 7586 primarily designated for the conservation of native plants and animals, their associated habitats and cultural diversity.
- u. "Non-governmental organization (NGO)" refers to an agency, institution, foundation or a group of persons whose purpose is to assist peoples organizations/associations in various ways including, but not limited to, organizing, education, training, research and/or resource accessing.
- v. "People's Organization (PO)" refers to a group of organized migrant communities and or interested indigenous peoples which may be an association, cooperative, federation, or other legal entity, established to undertake collective action to address community concerns and needs, and mutually share the benefits of the endeavor.
- w. "Protected Area" refers to the identified portions of land and/or water set aside by reason of their unique physical and biological significance, managed to enhance biological diversity and protected against destructive human exploitation.
- x. "Protected Area Management Board" refers to a multi-sectoral policy-making body for protected areas created in accordance with RA 7586 or the NIPAS Act of 1992;
- y. "Protected Landscape/Seascape" refers to an area of national significance which are characterized by the harmonious interaction of man and land while providing

opportunities for public enjoyment through recreation and tourism within the normal lifestyle and economic activity of these areas.

- z. "Quarrying" means the process of extracting, removing and disposing quarry resources found on or underneath the surface of private or public land.
- aa. "Sustainable use" means the use of components of biological diversity in a way and rate that does not lead to the long-term decline of biological diversity, thereby maintaining its potential to meet the needs and aspirations of present and future generations.

bb. "Tenured Migrants" refers to forest occupants who have actually and continuously occupied a portion of the ENTMRPA and is solely dependent therein for subsistence. A ENTMRPA occupant is understood to be "solely dependent for subsistence" when everything indispensable for survival for the household, including food, clothing, shelter and health, comes only from the utilization of resources from the ENTMRPA.

cc. "Trawl" refers to an active fishing gear consisting of a bag shaped net with or without otter boards to open its opening which is dragged or towed along the bottom or through the water columns to take fishery species by straining them from the water, including all variations and modifications of trawls (bottom, mid-water, and baby trawls) and tow nets.

dd. "Wildlife" means wild forms and varieties of flora and fauna, in all developmental stages, including those which are in captivity or are being bred or propagated.

Sec. 4. Scope and Boundaries - Given the physical, natural features and sociocultural and economic importance that contribute to its valuable role as life support system for the people living within and around it. The evaluation led to its establishment as a "Managed Resource Protected Area" as defined under the International Union for the Conservation of Nature (IUCN), to which the Philippines is a party to and in accordance with Section 3 (h) of Republic Act 7586 otherwise known as the "National Integrated Protected Areas System (NIPAS) Act".

The technical descriptions provided in this Act will be subject to ground survey and verification to be conducted by the Department of Environment and Natural Resources. Any modification of the coverage of this Act due to such factors as changing ecological situations, new scientific or archeological findings, or discovery of traditional boundaries not previously taken into account shall be made through an act of Congress, after consultation with the affected public and concerned government agencies.

Sec. 5. Management of the El Nido-Taytay Managed Resource Protected Area)

- There is hereby created a PAMB which shall have sole jurisdiction, power and
authority over the ENTMRPA for all matters that may affect biodiversity conservation,
protection and sustainable development. It shall be composed of:

- 34 (1) The Regional Executive Director (RED) of the DENR Region IV, as35 Chairperson;
 - (2) Provincial Planning and Development Officers of the Province of Palawan;

- (3) The Mayors of the Municipalities of El Nido and Taytay, Province of Palawan, or their duly designated representatives;
 - (4) One representative from each barangay covering the ENTMRPA;

- (5) At least two (2) representatives from local POs with stakes in the ENTMRPA, chosen from among themselves;
- (6) At least three (3) representatives from the local NGOs with stakes in the ENTMRPA, chosen from among themselves;
- (7) One representative from government agencies involved in the ENTMRPA management; and
- (8) One representative from each tribal community residing within the ENTMRPA:

Each member of the PAMB shall serve for a term of five (5) years and shall be considered to represent his or her sector and deemed to carry the vote of such sector in all matters. In the case of members who are government officials, the term of office shall be attached to the office held.

The members of the PAMB shall be appointed by the Secretary of the DENR in conformity with the provisions of the NIPAS Act. As a transitory provision, the initial members of the PAMB shall be nominated from the current members of the interim PAMBs of the five (5) component areas of the ENTMRPA. Their nominations shall be conducted in a joint meeting of the current members of the interim PAMBs duly called for the purpose: *Provided, further,* that at least one-third (1/3) of the members shall be women.

In the selection of the representatives of POs and NGOs, preference shall be accorded to those organizations that are involved in the conservation, protection and development of the ENTMRPA. Representation shall be by institution and shall aim to achieve balance in representation by geographic location or areas.

achieve balance in representation by geographic location or areas.

The representatives from the LGUs and national agencies in the PAMB shall include among their duty to appraise their respective constituents, office or sector, of PAMB approved or other relevant policies, rules, regulations, programs and projects and to ensure that the provisions of this Act are observed, complied with, and used as reference and framework in their respective plans, policies, programs and projects. Failure to comply with the foregoing shall subject such representative to disciplinary action as the PAMB may provide.

The members of the Board shall not receive any salary but shall be entitled to reimbursements for actual and necessary expenses incurred, either in their attendance in meeting of the Board or in connection with other official business authorized by a resolution of the Board, subject to existing rules and regulations.

- 1 SEC. 6. Powers and Functions of the PAMB. The PAMB of the ENTMRPA, which

- 18 raise funds for the ENTMRPA;

- 21 (9) Recommend appropriate policy changes to the DENR and other government
- 22 authorities.
- The DENR, through the Regional Executive Director (RED), shall ensure that the
- 24 PAMB acts within the scope of its powers and functions. In case of conflict between
- 25 administrative orders issued by the DENR pursuant to the NIPAS Act and the
- resolutions issued by the PAMB, such conflict shall be referred by PAMB to the DENR
- 27 Secretary who shall decide whether to apply the rule or withdraw its application from
- 28 the ENTMRPA.
- 29 SEC. 7. Protected Area Superintendent (PASu) Office. The Protected Area
- 30 Superintendent (PASu) Office is hereby created within the DENR Regional office to be

- 3 ENTMRPA and establish an office in order to implement this Act.
- 4 The PASu shall have full responsibility for the protection of land, water, wildlife and
- 5 other natural physical and biological resources within the ENTMRPA. As such, the
- 6 PASu shall have the following powers and functions in addition to those provided under
- 7 the NIPAS and its implementing rules and regulations:
- 8 (1) Establish, operate, and maintain a database management system as a decision
- 9 support tool;
- 10 (2) Prepare the management plan as herein defined;
- 11 (3) Provide a secretariat for the PAMB and supply the PAMB with all the necessary
- 12 information to make appropriate decisions for the implementation of this Act;
- 13 (4) Enforce the laws, rules and regulations relevant to the ENTMRPA, institute and file
- 14 legal action independently or in collaboration with other government agencies or
- organizations and assist in the prosecution of offenses committed in violation of this Act;
- 16 (5) Monitor all activities within the ENTMRPA to ensure its conformity with the
- 17 management plan;
- 18 (6) Ensure the integration of the ENTMRPA management policies, regulations,
- 19 programs and projects in all concerned national and local government unit levels;
- 20 (7) Recommend the issuance of permits based on terms, conditions and criteria
- 21 established by the PAMB; and
- 22 (8) Perform such other powers and duties as may from time to time be prescribed by the
- 23 PAMB and higher authorities.
- 24 SEC. 8. Indigenous People's Rights. Ancestral domain and other customary rights
- 25 and interests of indigenous communities within the ENTMRPA shall be accorded due
- 26 recognition. The preservation of ancestral domain and customary rights shall be
- 27 considered as one of the management objectives. The maintenance, management and
- 28 development of ancestral domains which are found to be necessary for ENTMRPA will
- 29 be pursuant to Section 58 of Republic Act No. 8371, otherwise known as the "The
- 30 Indigenous Peoples Rights Act of 1997 (IPRA)".
- 31 The identification, delineation and recognition of ancestral domain claims within the
- 32 ENTMRPA shall be conducted by the National Commission on Indigenous Peoples
- 33 (NCIP) pursuant to the provisions the IPRA, and its implementing rules and regulations,

- 1 in coordination with the PAMB.
- 2 SEC. 9. Tenured Migrants and Other ENTMRPA Occupants. –Tenured migrants shall
- 3 be eligible become stewards of portions of lands within allowable zones. The PAMB
- 4 shall identify, verify and review all tenurial instruments, land claims, and issuances of
- 5 permits for resource use within the ENTMRPA and recommend the issuance of the
- 6 appropriate tenurial instrument consistent with the zoning provided in the management
- 7 plan.
- 8 Should areas occupied by tenured migrants be designated as zones in which no
- 9 occupation or other activities are allowed pursuant to the attainment of sustainable
- development, provision for the transfer of said tenured migrants to multiple-use zones or
- 11 buffer zones shall be accomplished through just and humane means.
- 12 In the event of termination of a tenurial instrument for cause or by voluntary surrender of
- rights, the PASu shall take immediate steps to rehabilitate the area in order to return it
- 14 to its natural state prior to the cultivation or other act by the tenured migrant.
- 15 Other ENTMRPA occupants who do not qualify as tenured migrants shall be resettled
- outside the ENTMRPA as determined by the PAMB. The PAMB shall determine, plan
- and implement a definite schedule for resettling them outside of the ENTMRPA
- 18 following the procedures set forth by existing law.
- 19 SEC. 10. Prohibited Acts and Penalties. The following shall be the
- 20 prohibitions and penalties applicable to the ENTMRPA, in addition to the prohibited acts
- as provided in the NIPAS Act and its pertinent rules and regulations:
- 22 (A) The penalties provided for in Articles 309 and 310 of the Revised Penal Code,
- 23 depending on the value of the resources taken, damaged or destroyed, shall be
- 24 imposed upon any person who:
- 25 (1) Takes, destroys, collects, disturbs or possesses any wild terrestrial or aquatic plants
- or animals, flora or fauna, sand, rocks or by-products derived therefrom, within
- 27 particularly identified regulated or prohibited areas zones in the ENTMRPA including
- private lands without the necessary permit, authorization or exemption: *Provided,* That
- 29 hunting of animals shall be absolutely prohibited except for scientific research and for
- 30 traditional hunting by the iPs/ICCs;
- 31 (2) Cuts, gathers, removes or collects timber or any forest products, within particularly
- 32 identified regulated or prohibited areas or zones in the ENTMRPA including private
- 33 lands without the necessary permit, authorization or exemption;

- 1 (3) Possesses or transports, within or outside the ENTMRPA any timber, forest
- 2 products, wild terrestrial or aquatic plants, animals, flora or fauna, or by-product derived
- 3 therefrom which is ascertained to have been taken from the ENTMRPA;
- 4 (4) Undertakes mineral exploration or extraction within the ENTMRPA;
- 5 (5) Engages in quarrying of sand, gravel, guano, limestone or any material within the
- 6 ENTMRPA;
- 7 (6) Hunts, collects, removes or destroys any endangered or protected species, except
- 8 when collection or removal is for scientific research and exempted from the prohibition
- 9 by the PAMB;
- 10 (7) Conducts bioprospecting within the ENTMRPA without prior PAMB approval in
- 11 accordance with existing guidelines; or
- 12 (8) Establishes or introduces exotic species within the ENTMRPA which are detrimental
- to endemic species or without prior PAMB approval.
- 14 (B) A fine of not less than Five thousand pesos (P5,000.00) nor more than Five hundred
- thousand pesos (P500,000.00) and/or imprisonment from one (1) year but not more
- than six (6) years shall be imposed upon any person who:
- 17 (1) Violates any rules and regulations in the management plan or by the PAMB or
- agreements reached before the PAMB in the exercise of adjudicative functions;
- 19 (2) Erects any structure on land or on water for any purposes outside the management
- 20 plan: Provided, That large-scale private infrastructure and other projects such as
- 21 medium to high density residential subdivisions, medium to large commercial and
- 22 industrial establishments, golf-courses, heavily mechanized commercial and non-
- 23 traditional farming, and other activities that cause increased in-migration, pollution and
- 24 resource degradation are absolutely prohibited;
- 25 (3) Possesses a chainsaw, hacksaw and other mechanized equipment within the
- **26** ENTMRPA without a permit;
- 27 (4) Throws, dumps or causes to be dumped into the ENTMRPA any non-biodegradable
- 28 material or waste whether liquid, solid or gas;
- 29 (5) Uses, dumps, places or causes to be placed into the ENTMRPA toxic chemicals,
- 30 including pesticides and other hazardous substances, unless the same is expressly
- 31 allowed in the management plan;
- 32 (6) Prospects, hunts or otherwise locates hidden treasures within the
- 33 ENTMRPA;
- 34 (7) Informally occupies or dwells in any land within the ENTMRPA without clearance
- **35** from the PAMB;
- 36 (8) Posseses or uses blasting caps or explosives anywhere within the ENTMRPA;

- 1 (9) Destroys, excavates, vandalizes or, in any manner, damages any natural formation
- 2 on land, religious, spiritual, historical sites, artifacts and other objects of natural or
- 3 scenic value;
- 4 (10) Alters, removes or destroys boundary marks or signs;
- 5 (11) Engages in kaingin, or, in any manner, causing forest fires inside the ENTMRPA; or
 - 6 (12) Purchases, or sells, mortgages or leases lands or other portions of the ENTMRPA
 - 7 which are covered by any tenurial instrument.
 - 8 Valuation of the damage for this Act shall take into account biodiversity and
 - 9 conservation considerations as well as aesthetic and scenic value. Valuation assessed
- 10 by the DENR or the concerned government agency shall be presumed correct unless
- 11 otherwise proven by preponderant evidence.
- 12 Any person who shall induce another or conspire to commit any of the illegal acts
- 13 prohibited in this Act or suffer their workers to commit any of the same shall be liable in
- 14 the same manner as the one actually performing the act.
- 15 All conveyances, vessels, equipments, paraphernalia, implements, gears, tools and
- 16 similar devices shall be subject to immediate and administrative confiscation,
- 17 independent of the judicial proceedings by the PASu Office upon apprehension, subject
- 18 however to due process and substantial evidence requirements. When legal action is
- 19 however filed in the regular courts, the said conveyances, vessels, equipments,
- 20 paraphernalia, implements, gears, tools and similar devices, independent of the
- 21 administrative proceedings, shall not be released until after judgment has been
- 22 rendered. Proceeds of the sale of all objects administratively or judicially confiscated
- 23 pursuant hereto shall accrue to the ENTMRPA Fund. Procedure for the sale thereof
- 24 shall be promulgated by the PAMB. However, in no case shall any confiscated or
- 25 rescued protected animal species be sold or in any manner disposed of but shall be
- immediately turned over to the PASu office for release in its natural habitat, subject to
- 27 existing regulations.
- 28 The penalties specified in this Section will be in addition to the penalties contained in
- 29 RA 9072 (National Caves and Cave Resources Management and Protection Act), RA
- 30 9147 (Wildlife Resources Conservation and Protection Act), and other related laws.
- 31 Conviction for any offense under this Act, of a public officer or officer of the law shall

1 carry the accessory penalty of perpetual disqualification from public office.

2 SEC. 11. Special Prosecutor and Retained Counsel. – Within thirty (30) days from the

effectivity of this Act, the Department of Justice (DOJ) shall appoint a special prosecutor

to whom all cases of violation of laws, rules and regulations in the ENTMRPA shall be

assigned. Such Special Prosecutor shall coordinate with the PAMB and the PASu in

the performance of his/her duties and assist in the training of wardens and rangers in

arrest and criminal procedures. The PAMB may retain the services of a counsel to

prosecute and/or assist in the prosecution of cases under the direct control and

supervision of the regular or special prosecutor and to defend the members of the

PAMB, the PASu and the staff, or any person assisting in the protection, conservation

and sustainable development of the ENTMRPA, against any legal action related to their

powers, functions and responsibilities as provided in this Act or as delegated or tasked

13 by the PAMB.

14 SEC. 12. El Nido-Taytay Managed Resource Protected Area Fund. –There is hereby

established a trust fund to be known as the El Nido-Taytay Managed Resource

Protected Area Fund for purposes of financing projects of the ENTMRPA. Seventy-five

percent (75%) income generated from the operation of the ENTMRPA or management

of wild flora and fauna in the ENTMRPA shall accrue to the fund. The remaining twenty-

five percent (25%) shall go to the Integrated Protected Areas Fund (IPAF) as

established in the NIPAS Act of 1992.

Income shall be derived from visitors/tourists fee, fees from permitted sale and export of flora and fauna and other resources from the ENTMRPA, proceeds from the registration and lease of multiple-use areas, including tourism concessions, fees, proceeds, and contributions from industries and facilities directly benefiting from the ENTMRPA, and such other fees and income derived from the operation of the ENTMRPA.

The PAMB may impose and charge reasonable fees, such as but not limited to water users fee for water extracted by commercial water extractors/distributors sourced and generated from the protected area. Such fee structure may change as the PAMB may see fit.

31 The Fund may be augmented by grants, donations, endowment from various sources,

domestic or foreign, for purposes related to their functions: *Provided*, disbursements

therefrom shall be made solely for the protection, maintenance, administration and

management of the system, and duly approved projects endorsed by the PAMB in

accordance with existing accounting and budgeting rules and regulations: Provided,

- 1 further, That the Fund shall not be used to cover personal services expenditures.
- 2 The LGUs shall continue to impose and collect all other fees not enumerated herein
- 3 which they have traditionally collected, such as business permits, property tax and
- 4 rentals of LGUs' facilities. Provided, LGUs may charge add-ons to fees imposed by the
- 5 PAMB: Provided, That such add-ons shall be determined based on the contribution of
- 6 the LGUs in the maintenance and protection of the ENTMRPA.
- 7 SEC. 13. Existing Facilities Within the ENTMRPA. Within sixty (60) days from the
- 8 effectivity of this Act, major existing facilities such as roads, buildings, water systems,
- 9 transmission lines, communication facilities, heavy equipment, and irrigation facilities
- 10 existing within the boundaries of the ENTMRPA shall submit project description to the
- 11 PAMB through the PASu.
- 12 The PAMB, with the assistance of the DENR, shall determine whether the existence of
- such facility and its future plan and operations will be detrimental to the ENTMRPA or
- 14 whether conditions for its operation shall be imposed. If any such conditions are
- violated, the owner of the facility shall be liable to pay a fine of Five Thousand Pesos
- 16 (P5,000.00) for every violation. Upon reaching a total fine of Five Hundred Thousand
- 17 Pesos (P500,000.00), the PAMB through the PASu and deputizing other government
- 18 entities, shall cause the cessation and demolition of the facility at the cost of its owner.
- 19 Existing facilities allowed to remain within the ENTMRPA may be charged a reasonable
- 20 royalty by the DENR. All income from such royalty shall accrue to the ENTMRPA Fund.
- 21 SEC. 14. *Utilization of Resources.* Any exploitation of or utilization of nonrenewable
- resources within the ENTMRPA shall not be allowed. Energy projects-within the
- 23 ENTMRPA shall be allowed only through an act of Congress except energy from wind,
- sun and water sources of not more than one (1) megawatt capacity for mini-hydro
- 25 power: Provided, That these renewable energy projects are established outside the
- 26 strict protection zone, adopt reduced impact technologies and undergo the
- 27 environmental impact assessment (EIA) system as provided by law and: Provided,
- 28 Further, that the PAMB endorsement has been obtained.
- 29 SEC. 15. Appropriations. The Secretary of the DENR shall include in its program the
- implementation of this Act, the funding of which shall be included in the annual General
- 31 Appropriations Act.
- 32 SEC. 16. Construction and Suppletory Application of Existing Laws. The provisions of

- 1 this Act shall be construed liberally in favor of achieving biodiversity conservation,
- 2 protection and sustainable development Provisions of Republic Act No. 7586, otherwise
- 3 known as the National Integrated Protected Areas Management Act of 1992 and
- 4 existing forestry laws, and their corresponding rules and regulations not inconsistent
- 5 hereto shall have the suppletory effect in the implementation of this Act.
- 6 SEC. 17. Transitory Provisions. In order to ensure the recovery and restoration of
- 7 biological diversity and to develop sustainable livelihood opportunities for tenured
- 8 migrants, the DENR shall henceforth cease to issue concessions, licenses, permits,
- 9 clearances, compliance documents or any other instrument that allows exploitation and
- 10 utilization of resources within the ENTMRPA until the management plan shall have been
- 11 put into effect.

All existing land use and resource use permits within the ENTMRPA shall be reviewed and shall not be renewed upon their expiration unless consistent with the management plan and approved by the PAMB. Moreover, areas determined by wildlife habitat and potable water sources and reservoirs shall be declared protected and special use zones, respectively, and their management and uses shall be consistent with the provision of the respective executive orders, presidential proclamations and amendments establishing them.

- 19 SEC. 18. Reporting Responsibility. The PASu, through the PAMB, shall submit an
- 20 annual accomplishment report to the Secretary of the DENR on the activities
- 21 undertaken in the ENTMRPA.
- SEC. 19. Separability Clause. If, for any reason, any part or section of this Act is declared invalid or unconstitutional, such other parts not affected thereby shall continue to be in full force and effect.
- 25 SEC. 20. Repealing Clause. -All laws, decrees, proclamations, rules and regulations
- inconsistent with the provisions of this Act are hereby repealed or modified accordingly.
- 27 SEC. 21. Effectivity Clause. This Act shall take effect fifteen (15) days after its complete
- 28 publication in the Official Gazette or in a national newspaper of general circulation
- 29 available in the ENTMRPA.
