




The Old Senate Session Hall was located within the former Legislative Building in Manila (now known as the National Museum of Fine Arts) and was the venue for legislative sessions from 1926 to 1996. Built during the American colonial period, the Legislative Building was inaugurated on July 16, 1926 with the opening of the Second Session of the Seventh Philippine Legislature in the presence of Senate President Manuel L. Quezon, House Speaker Manuel A. Roxas, and the Members of the Legislature. When the Congress of the Philippines was dissolved in 1972, the Old Senate Session Hall was closed. The Senate was reestablished in 1987 and returned to the Legislative Building. The Old Senate Session Hall was again closed in 1996 after the Senate moved to its new home in Pasay City.









