

1 Unit Supply of labor, materials, delivery and installation of one (1) unit Wall Mounted, Inverter aircon with 2.0 HP cooling capacity with matching air cooled condensing including standard accessories, wireless remote controller.

SCOPE OF WORK

1. dismantling of existing old 3hp wall-mounted and installation of one (1) unit brand new 2.0hp air-conditioning unit, wall-mounted (indoor and outdoor unit).
2. use existing feeder line except for the control wires (3.5mm THNN/THWN) copper wire of the FCU.
3. provide one set 30A/230V/10/60 Hz circuit breaker, bolt-on type as a service unit cut-off and main protection for the unit in NEMA 3R enclosure.
4. use circuit breaker as a main protection at the designated panel located at the electrical room.
5. Supply and installation of new refrigerant field piping with insulation and wrap around with blue polyethylene tape.
6. Supply and installation of new condensate drain piping.
7. Supply and installation of new supports, bracket and hangers.
8. System flushing, leak testing and dehydration works.
9. Charging of new refrigeration R410.
10. Installation of new filter drier.
11. Restoration of wall affected by piping layout.
12. Testing and commissioning.
