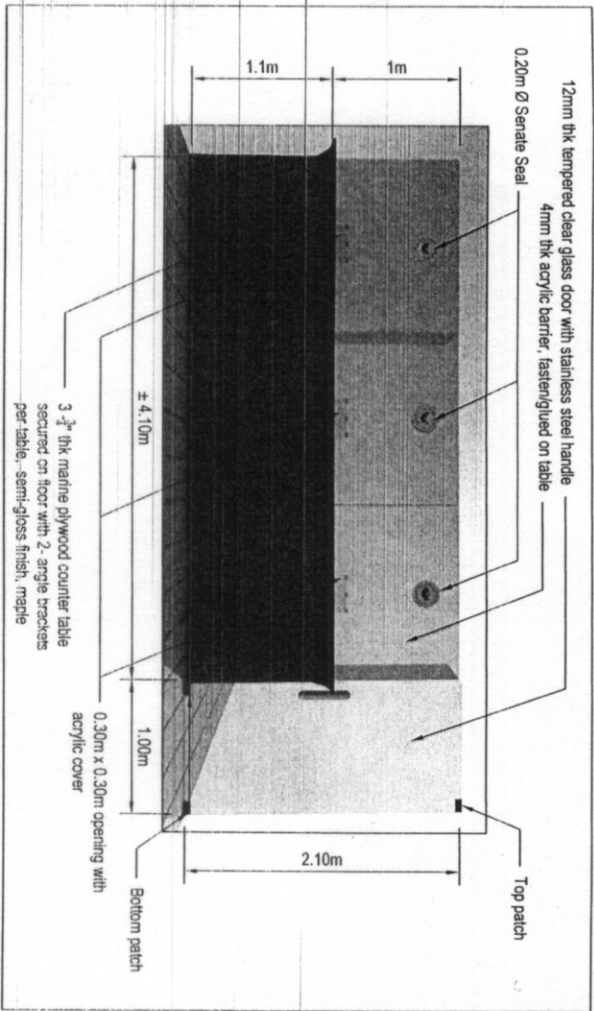

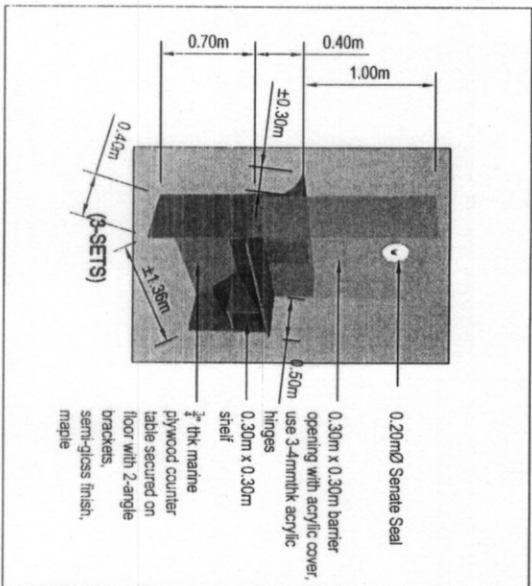

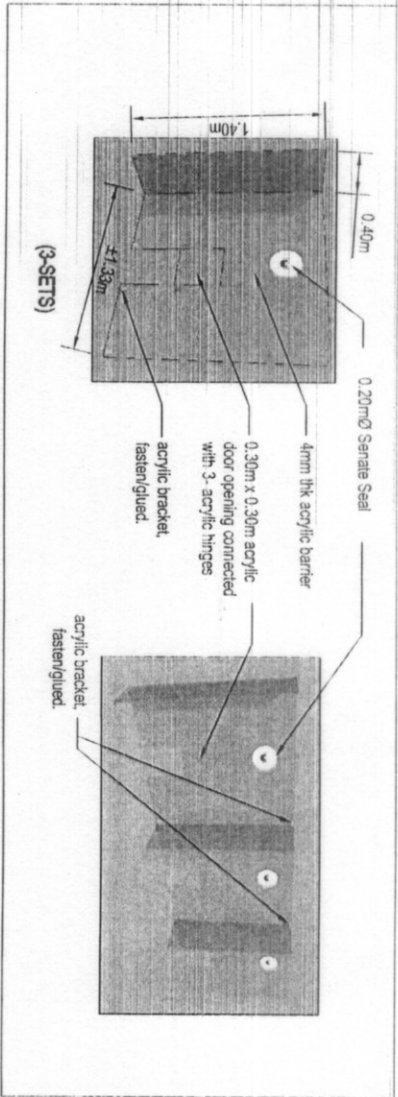

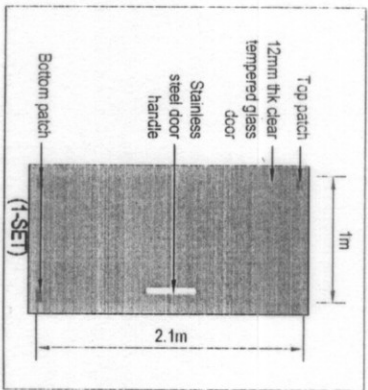
Front View
 SCALE 1:50 MTS



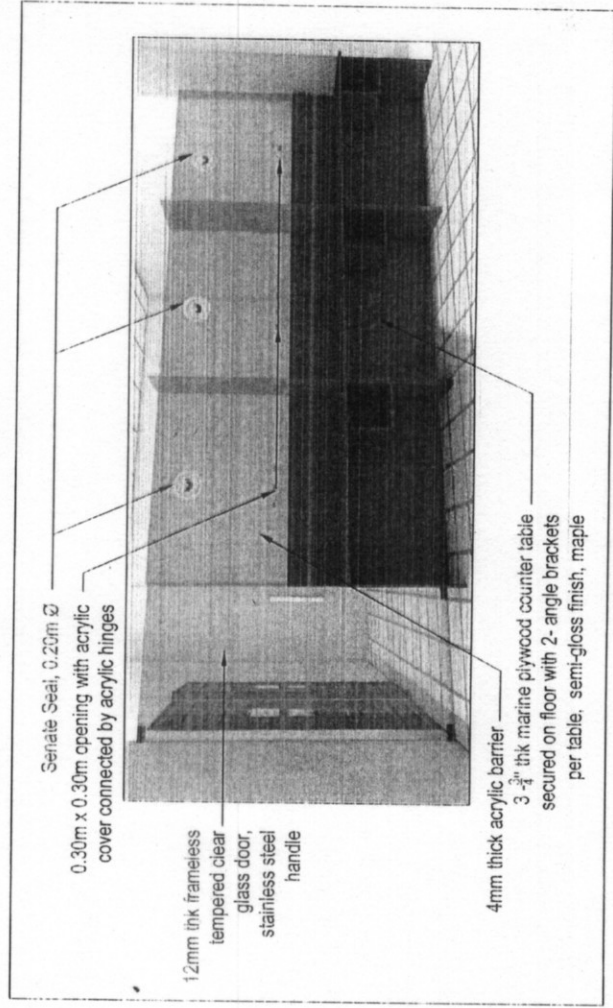
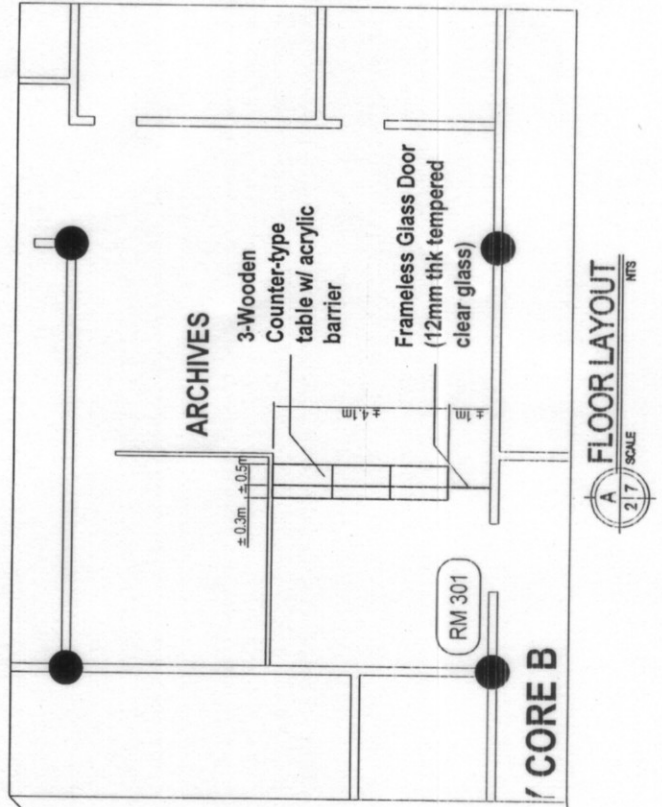
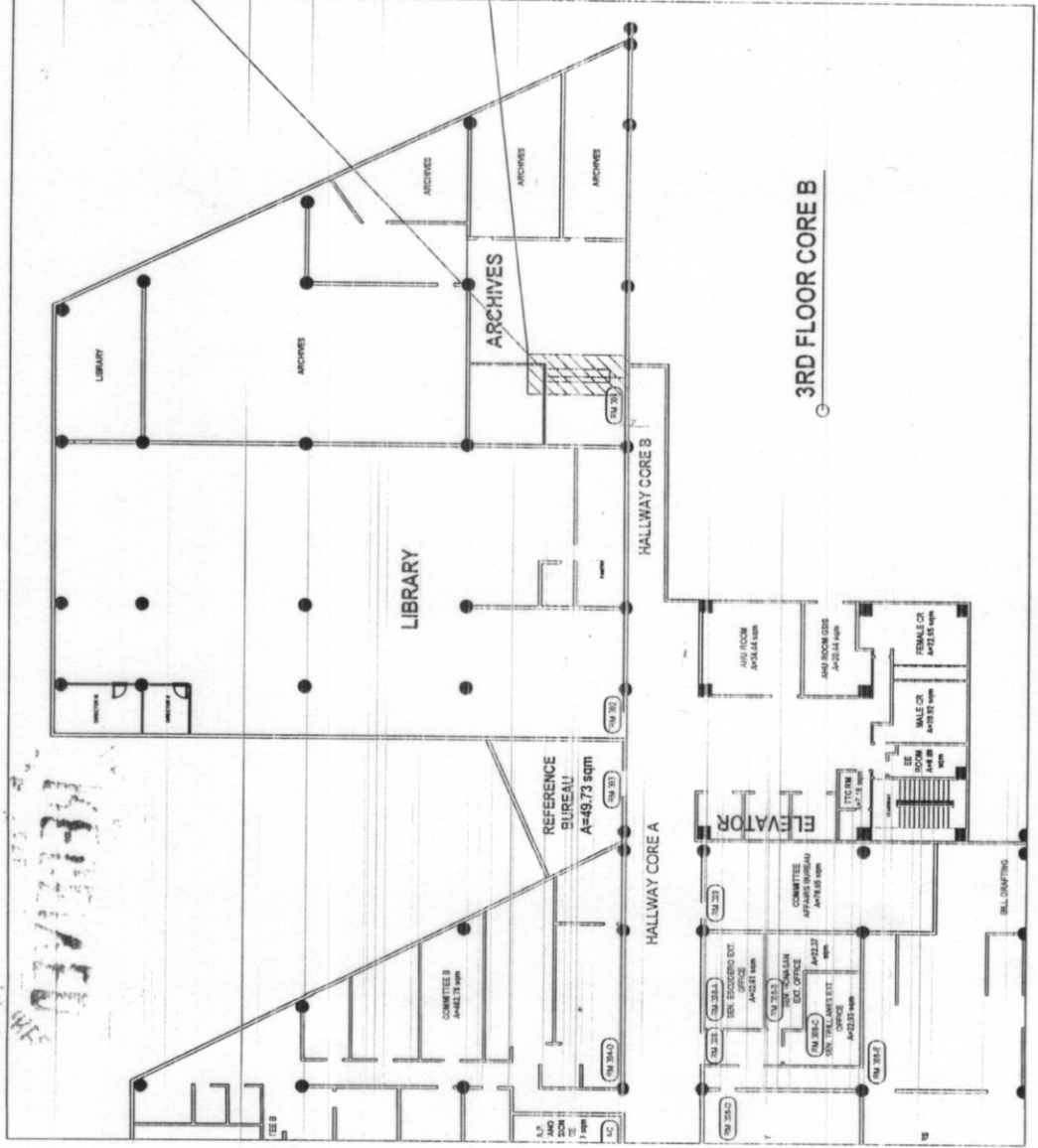
Counter Table Detail
