



AN ACT ESTABLISHING THE SORSOGON SECOND DISTRICT
ENGINEERING OFFICE IN THE PROVINCE OF SORSOGON AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. There shall be established, under the supervision of the
2 Department of Public Works and Highways, a second district engineering
3 office in the Second Congressional District of the Province of Sorsogon to be
4 located in the Municipality of Bulan, to be known as the Sorsogon Second
5 District Engineering Office.

6 SEC. 2. The said district engineering office shall comprise the
7 municipalities of Barcelona, Prieto Diaz, Gubat, Juban, Bulusan, Irosin,
8 Sta. Magdalena, Matnog and Bulan.

1 SEC. 3. The Secretary of Public Works and Highways shall include in
2 the Department's program the operationalization of the Sorsogon Second
3 District Engineering Office, the funding of which shall be included in the
4 annual General Appropriations Act.

5 SEC. 4. This Act shall take effect upon its approval.
