

introduced by Representative Roger G. Mercado, entitled:



- AN ACT RENAMING THE LILOAN BRIDGE IN THE LONE DISTRICT OF SOUTHERN LEYTE AS DIOSDADO PANGAN MACAPAGAL BRIDGE
- Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:
- 1 SECTION 1. The Liloan Bridge in the lone district of Southern Leyte
- 2 shall hereafter be known as Diosdado Pangan Macapagal Bridge.
- 3 SEC. 2. The Department of Public Works and Highways shall issue the
- 4 necessary rules, orders and circulars to implement the provision of this Act.
- 5 SEC. 3. This Act shall take effect fifteen (15) days after its publication
- 6 in a newspaper of general circulation.
