AN ACT SEPARATING THE MABA-AY NATIONAL HIGH SCHOOL –  
BANSAN ANNEX IN BARANGAY BANSAN, MUNICIPALITY OF  
BAUKO, MOUNTAIN PROVINCE FROM THE MABA-AY  
NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN  
INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS  
BANSAN NATIONAL HIGH SCHOOL AND APPROPRIATING  
FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

- 1           SECTION 1. *Separation and Conversion into a National High School.*  
2    – The Maba-ay National High School – Bansan Annex in Barangay Bansan,  
3    Municipality of Bauko, Mountain Province is hereby separated from the  
4    Maba-ay National High School and converted into an independent national  
5    high school to be known as Bansan National High School.  
6           SEC. 2. *Transfer of Assets and Liabilities.* – All personnel, assets,  
7    liabilities and records of the Maba-ay National High School – Bansan Annex are  
8    hereby transferred to and absorbed by the Bansan National High School.

1           SEC. 3. *Appropriations.* – The Secretary of Education shall  
2 immediately include in the Department's program the operationalization of the  
3 Bansa National High School, the initial funding of which shall be charged  
4 against the current year's appropriations of the Maba-ay National High School  
5 – Bansa Annex. Thereafter, the amount necessary for the continued operation  
6 of the school shall be included in the annual General Appropriations Act.

7           SEC. 4. *Implementation.* – The Secretary of Education shall issue rules  
8 and regulations that may be necessary to carry out the purpose of this Act.

9           SEC. 5. *Effectivity.* – This Act shall take effect fifteen (15) days after  
10 its publication in the *Official Gazette*.
