AN ACT SEPARATING THE CAGUBATAN NATIONAL HIGH SCHOOL – AM-AM ANNEX IN BARANGAY CADAD-ANAN, MUNICIPALITY OF TADIAN, MOUNTAIN PROVINCE FROM THE CAGUBATAN NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS AM-AM NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR.

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. *Separation and Conversion into a National High School.*
2 – The Cagubatan National High School – Am-am Annex in Barangay
3 Cadad-anan, Municipality of Tadian, Mountain Province is hereby separated
4 from the Cagubatan National High School and converted into an independent
5 national high school to be known as Am-am National High School.

6 SEC. 2. *Transfer of Assets and Liabilities.* – All personnel, assets,
7 liabilities and records of the Cagubatan National High School – Am-am Annex
8 are hereby transferred to and absorbed by the Am-am National High School.

1 SEC. 3. *Appropriations.* – The Secretary of Education shall
2 immediately include in the Department's program the operationalization of the
3 Am-am National High School, the initial funding of which shall be charged
4 against the current year's appropriations of the Cagubatan National High
5 School – Am-am Annex. Thereafter, the amount necessary for the continued
6 operation of the school shall be included in the annual General Appropriations
7 Act.

8 SEC. 4. *Implementation.* – The Secretary of Education shall issue rules
9 and regulations that may be necessary to carry out the purpose of this Act.

10 SEC. 5. *Effectivity.* – This Act shall take effect fifteen (15) days after
11 its publication in the *Official Gazette*.
