



AN ACT ESTABLISHING AN ANNEX OF THE MAKINHAS NATIONAL
HIGH SCHOOL TO BE LOCATED IN BARANGAY CIABU, CITY
OF BAYBAY, PROVINCE OF LEYTE TO BE KNOWN AS
MAKINHAS NATIONAL HIGH SCHOOL ANNEX AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Establishment of an Annex High School.* – There is hereby
2 established, under the supervision of the Department of Education, an annex of
3 the Makinhas National High School in Barangay Ciabu, City of Baybay,
4 Province of Leyte to be known as Makinhas National High School Annex.

5 SEC. 2. *Appropriations.* – The Secretary of Education shall
6 immediately include in the Department's program the operationalization of the
7 Makinhas National High School Annex, the funding of which shall be included
8 in the annual General Appropriations Act.

9 SEC. 3. *Implementation.* – The Secretary of Education shall issue rules
10 and regulations that may be necessary to carry out the purpose of this Act.

11 SEC. 4. *Effectivity.* – This Act shall take effect fifteen (15) days after
12 its publication in the *Official Gazette*.
