AN ACT SEPARATING THE NUEVA VIZCAYA GENERAL COMPREHENSIVE HIGH SCHOOL – PAIMA ANNEX IN BARANGAY PAITAN, MUNICIPALITY OF BAYOMBONG, PROVINCE OF NUEVA VIZCAYA FROM THE NUEVA VIZCAYA GENERAL COMPREHENSIVE HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS PAIMA NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION I. Separation and Conversion into a National High School

The Nueva Vizcaya General Comprehensive High School - Paima Annex in

3 Barangay Paitan, Municipality of Bayombong, Province of Nueva Vizcaya is

4 hereby separated from the Nueva Vizcaya General Comprehensive High

5 School and converted into an independent national high school to be known as

6 Paima National High School.

7 SEC. 2. Transfer of Assets and Liabilities. - All personnel, assets,

8 liabilities and records of the Nueva Vizcaya General Comprehensive High

- School Paima Annex are hereby transferred to and absorbed by the Paima
 National High School.
- SEC. 3. Appropriations. The Secretary of Education shall immediately include in the Department's program the operationalization of the Paima National High School, the initial funding of which shall be charged against the current year's appropriations of the Nueva Vizcaya General Comprehensive High School Paima Annex. Thereafter, the amount necessary for the continued operation of the school shall be included in the annual General Appropriations Act.
 - SEC. 4. Implementation The Secretary of Education shall issue rules and regulations that may be necessary to carry out the purpose of this Act.
 - SEC. 5. Effectivity. This Act shall take effect fifteen (15) days after its publication in the Official Gazette.
