



AN ACT ESTABLISHING THE ILOCOS NORTE THIRD DISTRICT
ENGINEERING OFFICE IN THE PROVINCE OF ILOCOS NORTE
AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. There shall be established, under the supervision of the
2 Department of Public Works and Highways, a third district engineering office
3 in the Province of Ilocos Norte to be known as the Ilocos Norte Third District
4 Engineering Office.

5 SEC. 2. The said district engineering office shall be located in the First
6 Congressional District of Ilocos Norte and shall comprise the municipalities of
7 Solsona, Dingras, Banna, Piddig, Carasi, Marcos and Nueva Era.

8 SEC. 3. The Secretary of Public Works and Highways shall include in
9 the Department's program the operationalization of the Ilocos Norte Third
10 District Engineering Office, the funding of which shall be included in the
11 annual General Appropriations Act.

12 SEC. 4. This Act shall take effect fifteen (15) days after its publication
13 in a newspaper of general circulation.
