





AN ACT SEPARATING THE BAGUIO CITY NATIONAL HIGH SCHOOL  
– LOAKAN ANNEX IN THE CITY OF BAGUIO FROM THE  
BAGUIO CITY NATIONAL HIGH SCHOOL, CONVERTING IT  
INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE  
KNOWN AS MIL-AN NATIONAL HIGH SCHOOL AND  
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. *Separation and Conversion into a National High School.*  
2   – The Baguio City National High School – Loakan Annex in the City of  
3   Baguio is hereby separated from the Baguio City National High School and  
4   converted into an independent national high school to be known as Mil-an  
5   National High School.

6           SEC. 2. *Transfer of Assets and Liabilities.* – All personnel, assets,  
7   liabilities and records of the Baguio City National High School – Loakan  
8   Annex are hereby transferred to and absorbed by the Mil-an National High  
9   School.

1           SEC. 3. *Appropriations.* – The Secretary of Education shall  
2 immediately include in the Department’s program the operationalization of the  
3 Mil-an National High School, the initial funding of which shall be charged  
4 against the current year’s appropriations of the Baguio City National High  
5 School – Loakan Annex. Thereafter, the amount necessary for the continued  
6 operation of the school shall be included in the annual General Appropriations  
7 Act.

8           SEC. 4. *Implementation.* – The Secretary of Education shall issue rules  
9 and regulations that may be necessary to carry out the purpose of this Act.

10           SEC. 5. *Effectivity.* – This Act shall take effect fifteen (15) days after  
11 its publication in the *Official Gazette*.
