





AN ACT SEPARATING THE MARAGUSAN NATIONAL HIGH SCHOOL
- NEW ALBAY ANNEX IN BARANGAY NEW ALBAY,
MUNICIPALITY OF MARAGUSAN, PROVINCE OF
COMPOSTELA VALLEY FROM THE MARAGUSAN NATIONAL
HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT
NATIONAL HIGH SCHOOL TO BE KNOWN AS NEW ALBAY
NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS
THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

- 1 SECTION 1. *Separation and Conversion into a National High School.*
2 The Maragusan National High School - New Albay Annex in Barangay New
3 Albay, Municipality of Maragusan, Province of Compostela Valley is hereby
4 separated from the Maragusan National High School and converted into an
5 independent national high school to be known as New Albay National High
6 School.
7 SEC. 2. *Transfer of Assets and Liabilities.* - All personnel, assets,
8 liabilities and records of the Maragusan National High School - New Albay

1 Annex are hereby transferred to and absorbed by the New Albay National High
2 School.

3 SEC. 3. *Appropriations.* -- The Secretary of Education shall
4 immediately include in the Department's program the operationalization of the
5 New Albay National High School, the initial funding of which shall be charged
6 against the current year's appropriations of the Maragusan National High
7 School -- New Albay Annex. Thereafter, the amount necessary for the
8 continued operation of the school shall be included in the annual General
9 Appropriations Act.

10 SEC. 4. *Implementation.* -- The Secretary of Education shall issue rules
11 and regulations that may be necessary to carry out the purpose of this Act.

12 SEC. 5. *Effectivity.* -- This Act shall take effect fifteen (15) days after
13 its publication in the *Official Gazette*.
