





ANNEX IN BARANGAY UPPER ULIP, MUNICIPALITY OF
MONKAYO, PROVINCE OF COMPOSTELA VALLEY FROM THE
UNION NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN
INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS
ULIP NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS
THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

- 1 SECTION 1. *Separation and Conversion into a National High School.*
2 -- The Union National High School - Ulip Annex in Barangay Upper Ulip,
3 Municipality of Monkayo, Province of Compostela Valley is hereby separated
4 from the Union National High School and converted into an independent
5 national high school to be known as Ulip National High School.
6 SEC. 2. *Transfer of Assets and Liabilities.* - All personnel, assets,
7 liabilities and records of the Union National High School - Ulip Annex are
8 hereby transferred to and absorbed by the Ulip National High School.
