



AN ACT DECLARING AUGUST 10 OF EVERY YEAR A SPECIAL  
NONWORKING HOLIDAY IN SAN JOSE CITY, PROVINCE OF  
NUEVA ECIJA

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. August 10 of every year is hereby declared a special  
2 nonworking holiday in the City of San Jose, Province of Nueva Ecija to  
3 commemorate its creation as a city.

4           SEC. 2. This Act shall take effect upon its approval.
