
MR. PRESIDENT:

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. September 10 of every year is hereby declared to be a
2 special nonworking holiday in the City of San Jose del Monte, Province of
3 Bulacan to commemorate its founding day and to be known as the "Foundation
4 Day of the City of San Jose del Monte".

5 SEC. 2. This Act shall take effect upon its approval.
