Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. October 12 of every year is hereby declared a special – 2 nonworking public holiday in the Municipality of Getafe, Province of Bohol to 3 commemorate its founding anniversary and to be known as the "Getafe 4 Foundation Day".

SEC. 2. This Act shall take effect upon its approval. Approved,
