T. LACSON MEMORIAL NATIONAL HIGH SCHOOL

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. *Renaming of a National High School.* – The name of
2 Kapitan Ramon National High School in Barangay Kapitan Ramon, City of
3 Silay, Province of Negros Occidental is hereby changed to Don Felix T.
4 Lacson Memorial National High School.

5 SEC. 2. *Effectivity.* – This Act shall take effect fifteen (15) days after
6 its publication in the *Official Gazette*.
