
The Committee on Culture and the Arts joint with the Committees on Tourism; Ways and Means; and Finance will conduct a **TWG meeting** on **29 May 2024, Wednesday, 9:30 AM, at the Sen. Sotto Room, Second Floor, Senate of the Philippines**, on the following legislative measures pertaining to the proposed **QUIAPO HERITAGE ZONE ACT**:

1. **Senate Bill No. 1471** – AN ACT DECLARING QUIAPO DISTRICT IN THE CITY OF MANILA A NATIONAL HISTORICAL - CULTURAL HERITAGE ZONE, APPROPRIATE FUNDS THEREFOR, AND FOR OTHER PURPOSES *(by Senator Lapid)*
2. **Senate Bill No. 2324** – AN ACT DECLARING QUIAPO DISTRICT IN THE CITY OF MANILA A NATIONAL HERITAGE ZONE, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES *(by Senator Legarda)*
3. **House Bill No. 8664** – AN ACT DECLARING THE IMMEDIATE ENVIRONS OF QUIAPO CHURCH, PLAZA MIRANDA, SAN SEBASTIAN CHURCH, PLAZA DEL CARMEN, QUEZON BRIDGE, THE LIFE THEATRE OR OLD VILLONGCO BUILDING, AND OTHER BUILT HERITAGE WITH NOTABLE HISTORICAL AND CULTURAL SIGNIFICANCE AS NATIONAL HERITAGE ZONE, PROVIDING FOR THEIR RESTORATION, REHABILITATION, CONSERVATION, AND DEVELOPMENT, AND APPROPRIATING FUNDS THEREFOR
