Please be informed that the Committee on Health and Demography, joint with the Committees on Finance and Tourism, will conduct a Public Hearing and Inquiry, in Aid of Legislation on **Tuesday, March 12, 2024, starting at 10:00 a.m., at the Sen. Laurel Room, 2nd Floor, Senate of the Philippines, Pasay City**, on the following:

A. Public Hearing on the Establishment/Upgrading/Conversion/Renaming of Hospitals *(Jointly with the Committee on Finance)*

1. HBN 8214, introduced by Reps. Suarez, Marcos, Romualdez (F. M.) entitled:

An Act Establishing in the City of Lucena, Province of Quezon, a General Hospital to be Known as the Lucena City Hospital, and Appropriating Funds Therefor

2. HBN 8426, introduced by Reps. Garcia (A.), Garcia (M. A), Gato, et. al., entitled:

An Act Upgrading the Bataan General Hospital and Medical Center in the City of Balanga, Province of Bataan, to a Multi-Specialty Apex Hospital, Increasing Its Bed Capacity from Five Hundred (500) to One Thousand (1,000) Beds, and Appropriating Funds Therefor

3. HBN 8483, introduced by Reps. Nograles (J. F. F.) and Romualdo (J. J.), entitled:


