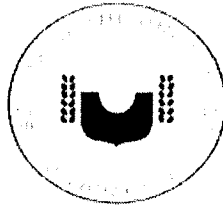

1. **Senate Bill No. 105** - AN ACT PROVIDING FOR A JUST AND HUMANE PUBLIC UTILITY VEHICLE (PUV) MODERNIZATION PROGRAM, WITH TRANSITORY ASSISTANCE AND SERVICES RENDERED TO PUV DRIVERS, OPERATORS AND

STAKEHOLDERS, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES (Introduced by Sen. Poe);
