1. **SBN 653** - AN ACT STRENGTHENING THE NATIONAL HOUSING AUTHORITY, EXTENDING ITS CORPORATE TERM, AND AMENDING FOR THIS PURPOSE PRESIDENTIAL DECREE NO. 757, ENTITLED 'CREATING THE NATIONAL HOUSING AUTHORITY AND DISSOLVING THE EXISTING

HOUSING AGENCIES, DEFINING ITS POWERS AND FUNCTIONS, PROVIDING FUNDS THEREFOR, AND FOR OTHER PURPOSES' (by: *Sen. Francis Tolentino*);

2. **SBN 1258** - AN ACT STRENGTHENING THE NATIONAL HOUSING AUTHORITY, EXTENDING ITS CORPORATE TERM, AMENDING FOR THE PURPOSE PRESIDENTIAL DECREE NO. 757 (by: *Sen. Joseph Victor Ejercito*); and
3. **SBN 1713** - AN ACT STRENGTHENING THE NATIONAL HOUSING AUTHORITY, EXTENDING ITS CORPORATE TERM, AND AMENDING FOR THIS PURPOSE PRESIDENTIAL DECREE NO. 757 (P.D. 757), CREATING THE NATIONAL HOUSING AUTHORITY AND DISSOLVING THE EXISTING HOUSING AGENCIES, DEFINING ITS POWERS AND FUNCTIONS, PROVIDING FUNDS THEREFOR, AND OTHER PURPOSES (by *Senator Imee R. Marcos*).
