Respectfully informing your Honors that the following measures are now secondarily referred from the Committee on Games and Amusement, to the Committee on Public Order and Dangerous Drugs:

PSR 225 - RESOLUTION DIRECTING THE COMMITTEE ON WAYS AND MEANS AND OTHER APPROPRIATE COMMITTEE/S OF THE SENATE TO CONDUCT AN INQUIRY, IN AID OF LEGISLATION ON THE REVENUES GENERATED BY THE GOVERNMENT FROM PHILIPPINE OFFSHORE GAMING OPERATORS (POGOS) VIS-À-VIS THE SOCIAL COSTS ATTENDANT TO THE OPERATION OF POGOS IN THE COUNTRY by Senator Joel Villanueva; and

PSR 227 - RESOLUTION DIRECTING THE APPROPRIATE SENATE COMMITTEE TO CONDUCT AN INQUIRY, IN AID OF LEGISLATION, ON THE GOVERNMENT'S REVENUE COLLECTION FROM THE IMPLEMENTATION OF REPUBLIC ACT NO. 11590 AND THE ECONOMIC AND SOCIAL COSTS INCURRED BY THE GOVERNMENT IN ADDRESING CRIMES RELATED TO THE PHILIPPINE OFFSHORE GAMING OPERATIONS INDUSTRY by Senator Win Gatchalian.
