

The result of the said Gender-Based Survey is shown below.














6. EMPLOYMENT STATUS






10. WHAT TYPE OF RESIDENTIAL UNIT DO YOU LIVE?




12. ARE YOU A SOLO PARENT?


14. HAVE YOU EVER FELT DISCRIMINATED/OFFENDED BECAUSE OF YOUR IDENTITY?


15. DO YOU KNOW SOMEONE WHO IS A VICTIM OF DISCRIMINATION?


16. ARE YOU INTERESTED TO ATTEND A PERSONAL ONE-ON-ONE COUNSELLING SESSION?


17. HAVE YOU EVER ATTENDED A GENDER SEMINAR/TRAINING?
