Explanatory Note

This bill aims to provide that no permit shall be required by the Secretary of the Department of Environment and Natural Resources (DENR) under the national pollutant discharge elimination system for the discharge from a recreational vessel of graywater, bilge water, cooling water, weather deck runoff, oil water separator effluent, or effluent from properly functioning marine engines or for any other discharge that is incidental to the normal operation of such vessel.

Further, this bill shall require the DENR Secretary to: (i) develop management practices for recreational vessels to mitigate the adverse impacts on the Philippine waters of discharges incidental to normal vessel operation (excluding sewage) in any case in which the Administrator determines that the use of those practices is reasonable and practicable; and (ii) promulgate national standards of performance (which may distinguish among vessel types) for each discharge for which such a management practice is developed.

This bill shall also require the Department of Transportation and Communication (DOTC) to promulgate regulations governing the design, construction, installation, and use of management practices for recreational vessels as necessary to meet such standards. Moreover, this bill, once enacted, shall prohibit the owner or operator of a recreational vessel from operating in Philippine waters if such owner or operator is not using applicable management practices in compliance with such regulations.

In view of the foregoing, the early passage of this bill is earnestly sought.

5	(1) Applicability This provision applies to any discharge, other than a discharge of sewage

9	(2) Determination Of Discharges Subject To Management Practices
10	(A) Determination
11	(i) In General The Secretary, in consultation with the Secretary of the
12	Department of Transportation and Communications (DOTC), the Secretary of Trade and
13	Industry (DTI), shall determine the discharges incidental to the normal operations of a
14	recreational vessel to enable the government to determine and develop reasonable and
15	practicable management practice to mitigate the adverse impacts of such discharge to Philippine

18	shall promulgate the standards of performance for each management practice required with

20	(B) Considerations In promulgating standards, the Secretary shall take into account the

16	(B) Regulations
17	(i) In General The Secretary shall promulgate the regulations under this Section as soon
18	as practicable after the Secretary promulgates standards with respect to the practice under
19	Section (4)(3), but not later than one (1) year after the date on which the Secretary promulgates
20	the standards.
21	(ii) Effective Date The regulations promulgated by the Secretary under this Section shall
22	be effective upon promulgation unless another effective date is specified in the regulations.
23	(iii) Consideration Of Time In determining the effective date of a regulation
24	promulgated under this Section, the Secretary shall consider the period of time necessary to
25	communicate the existence of the regulation to persons affected by the regulation.

SEC. 6. Prohibition Relating To Recreational Vessels After the effective date of the
regulations promulgated by the DOTC Secretary under Section 4, the owner or operator of a
recreational vessel shall neither operate in nor release any discharge incidental to the normal
operation of the vessel into, the waters of the Philippines or the waters of the contiguous zone, if
the owner or operator of the vessel is not using any applicable management practice meeting
standards established under this Act.

SEC. 7. Authorization of Appropriations.- The amount necessary to carry out the provisions of this Act shall be appropriated from the General Appropriations Act. Funds appropriated for this Act shall remain available until expended.

SEC. 8. Repealing Clause.- Any laws, decrees, ordinances or rules and regulations which are inconsistent with or contrary to the provision of this Act is hereby amended or repealed.

SEC. 9. Effectivity.- This Act shall take effect fifteen (15) days after its complete publication in at least two (2) national newspapers of general circulation.
