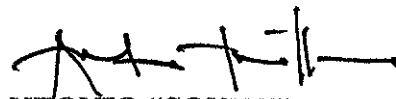
### EXPLANATORY NOTE

Article II, Section 16 provides that the State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature. However, recent data prove contrary to the aforementioned policy. Over the last 50 years, 66% of the forests in the Philippines were destroyed - one of the highest deforestation rates in the world.<sup>1</sup> These bleak conditions, compounded by looming climate change issues, call for state measures that involve not only the government but the whole community, as well.

It is in this light that this bill seeks to officially provide a revival of Arbor Day by mandating that all provinces, cities and municipalities with their component barangays to revive, by appropriate proclamation of their respective local chief executives, an Arbor Day at an appropriate fixed date every calendar year as shall be deemed suitable according to the proper time and season for planting trees in the respective provinces and their respective component municipalities or cities concerned.

The first Arbor Day was founded by American journalist J. Sterling Morton over 135 years ago. During the first Arbor Day, more than a million trees were planted in the State of Nebraska. His simple proposal of setting aside a special day for tree planting is now being practiced and celebrated worldwide. By following suit, it is hoped that this measure shall inculcate the value of tree-planting in every citizen and a deeper commitment towards environmental protection.

In view of the foregoing, immediate approval of this measure is earnestly sought.

**AN ACT**  
**TO PROVIDE THE REVIVAL OF ARBOR DAY BY VESTING IN PROVINCIAL, CITY AND MUNICIPAL GOVERNMENTS WITH THEIR COMPONENT BARANGAYS THE RESPONSIBILITIES FOR CELEBRATING THE DAY FOR TREE-PLANTING AS AN ANNUAL EVENT**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           **SEC. 1.** In order to emphasize the imperative necessity for maintaining proper ecological  
2 balance, for encouraging the beautification of communities and creating more healthful  
3 environments, it is hereby mandated that all provinces, cities and municipalities with their  
4 component barangays shall be required to revive, by appropriate proclamation of their respective  
5 local chief executives, an Arbor Day at an appropriate fixed date every calendar year as shall be  
6 deemed suitable according to the proper time and season for planting trees in the respective  
7 provinces and their respective component municipalities or cities concerned. Although adoption  
8 of uniform dates for every province and its component municipalities and the cities shall be  
9 encouraged, varying dates for Arbor Day celebrations may be permitted in order to afford  
10 flexibility in planning and in implementing tree-planting programs to adjust to the proper time  
11 and period of the year most suited to the trees selected to be planted, and as local budgetary  
12 allotments shall allow.

14           **SEC. 2.** In implementing the intents of this Act, there shall be created in every province,  
15 city and municipality an Arbor Day Celebrations Committee, the composition of which shall be  
16 selected or designated by the local chief executive concerned. The members of said committee  
17 shall preferably consist of officers based in the locality, representing, but not limited to:

- 1 (a) The local Sanggunian;
- 2 (b) The local Environment and Natural Resources Office;
- 3 (c) The Department of Environment and Natural Resources;
- 4 (d) The Department of Education;
- 5 (e) The Department of the Interior and Local Government;
- 6 (f) The Department of Agriculture;
- 7 (g) The Department of Agrarian Reform;
- 8 (h) The Department of Public Works and Highways;
- 9 (i) The Department of Tourism;
- 10 (j) The Philippine National Police;
- 11 (k) The Armed Forces of the Philippines;
- 12 (l) The Philippine Coconut Authority;
- 13 (m) Civic organizations;
- 14 (n) Youth organizations;
- 15 (o) Liga ng mga barangays; and
- 16 (p) Media associations.

18       **SEC. 3.** In order to assure active participation of students, out-of-school youths and  
19 employees of the government and private sectors, the Arbor Day designated every calendar year  
20 by each and every local government unit may be declared as a public holiday and such  
21 declaration may be embodied in the appropriate proclamation that local chief executives are in  
22 this Act authorized to do.

24       **SEC. 4.** The local Sanggunian shall promulgate the rules and regulations, including the  
25 allocation of resources pertinent to the implementation of this Act at their respective local  
26 government level. For information and monitoring purposes, the respective local government  
27 units shall submit to the Department of the Interior and Local Government (DILG), copy  
28 furnished the Department of Environment and Natural Resources (DENR), the official date of  
29 the specified Arbor Day.

1           **SEC. 5.** The DILG, in coordination with the DENR, shall promulgate the rules and  
2 regulations to effectively implement the provisions of this Act.

4           **SEC. 6.** This Act shall take effect fifteen (15) days following its complete publication in  
5 the *Official Gazette* or in at least two (2) newspapers of general circulation.
