	Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:
1	SECTION 1. Establishment of a National High School There is hereby
2	established, under the supervision of the Department of Education, a national
3	high school in Barangay San Roque, City of Marikina to be known as San
4	Roque National High School.
5	SEC. 2. Appropriations The Secretary of Education shall
6	immediately include in the Department's program the operationalization of the
7	San Roque National High School, the funding of which shall be included in the
8	annual General Appropriations Act.
9	SEC. 3. Implementation The Secretary of Education shall issue rules
10	and regulations that may be necessary to carry out the purpose of this Act.
11	SEC. 4. Effectivity This Act shall take effect fifteen (15) days after
12	its publication in the Official Gazette.
