BY REPRESENTATIVE UY (R.A.), PER COMMITTEE REPORT NO. 277

AN ACT ESTABLISHING THE CAGAYAN DE ORO CITY FIRST DISTRICT ENGINEERING OFFICE AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The district engineering office in Cagayan De Oro City,
2 under the supervision of the Department of Public Works and Highways, shall
3 be reconstituted into two (2) separate district engineering offices. The first
4 district engineering office to be located in Barangay Carmen shall be known as
5 the Cagayan De Oro City First District Engineering Office and the existing
6 district engineering office located in Barangay Macabalan shall be known as
7 the Cagayan De Oro City Second District Engineering Office.

8 SEC. 2. The said Cagayan De Oro City First District Engineering
9 Office shall comprise the barangays of Carmen, Bulua, Kauswagan, Iponan,

1 Balulang, Canitoan, Lumbia, Patag, Mambuaya, San Simon, Dansolihon,
2 Taglimao, Tagpangi, Bisigan, Bayanga, Tignapoloan, Pigsag-an, Pagalungan,
3 Pagatpat, Tumpagon, Bayabas, Bonbon, Baikingon and Tuburan; while the
4 Cagayan De Oro City Second District Engineering Office shall comprise the
5 remaining barangays of Macabalan, Puntod, Consolacion, Camaman-an
6 Nazareth, Macasandig, Indahag, Lapasan, Gusa, Cugman, FS Catanico,
7 Tablon, Agusan, Puerto, Bugo, Balubal and all urban barangays from
8 Barangay 1 to Barangay 40.

9 SEC. 3. The Secretary of Public Works and Highways shall include in
10 the Department's program the operationalization of the Cagayan De Oro City
11 First District Engineering Office, the funding of which shall be included in the
12 annual General Appropriations Act.

13 SEC. 4. The relevant provisions of Sections 1 and 2 of Republic Act
14 No. 9066, and all other laws, decrees, orders, rules and regulations are hereby
15 modified or amended accordingly.

16 SEC. 5. This Act shall take effect upon its approval.
