## HOUSE OF REPRESENTATIVES

AN ACT ESTABLISHING A NATIONAL HIGH SCHOOL IN BARANGAY MARONQUILLO, MUNICIPALITY OF SAN RAFAEL, PROVINCE OF BULACAN TO BE KNOWN AS MARONQUILLO NATIONAL HIGH SCHOOL AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. Establishment of a National High School. - There is 2 hereby established, under the supervision of the Department of Education. 3 national high school in Barangay Maronquillo, Municipality of San Rafae. Province of Bulacan to be known as Maronquillo National High School. 4 SEC. 2. Appropriations. - The Secretary of Education 5 6 immediately include in the Department's program the operationalization or 7 Maronquillo National High School, the funding of which shall be included in 8 the annual General Appropriations Act. 9 SEC. 3. Implementation. – The Secretary of Education shall issue such 10 rules and regulations as may be necessary to carry out the purpose of this Act. 11 SEC. 4. Effectivity. - This Act shall take effect fifteen (15) days after its publication in the Official Gazette. 12 -Approved,
